## European Court of Human Rights: the application of criminal law principles

### Obiettivi formativi:

Questo corso offre agli studenti la possibilità di prendere coscienza dell'evoluzione e degli attuali paradigmi operativi della Convenzione EDU con riferimento al diritto penale. Insiema ai principi basilari della materia, il conrso si prefigge di analizzare le problematiche di maggior rilievo in punto di giustizia penale.

This course offers to the students the opportunity to become acquainted with the evolution and the current framework of ECHR Law in criminal matters. Together with the basics and principles of the subject, the course also provides insights into some outstanding problems related to Criminal Justice.

### Contenuto e articolazione del corso:

Questo corso esplora il sistema della Carta EDU attraverso l'analisi:

- della storia e dell'operatività della Corte;
- dell'applicazione dei principi della convenzione da parte della Corte in ambito penale;
- del diritto vivente della Corte EDU con particolare riferimento alla tutela dei diritti fondamentali degli indagati e delle vittime.

This course explores the system of the "European Convention on Human Rights" throuh the analysis of:

- the history and the Court operation;
- the application of the principles of the Convention by the ECHR in Criminal matters;
- the case-law of the "European Court of Human Rights" focused with regard to the protection of the fundamental rights of both the suspect and the victims.

### Conoscenze e competenze che saranno acquisite:

L'obbiettivo del corso è quello di fornire agli studenti le seguenti abilità:

- comprensione dei principi della Convenzione con riferimento alla materia penale;
- conoscenza delle funzioni della Corte EDU;
- l'abilità di conoscere il diritto vivente della CEDU;
- l'abilità di argomentare a sostegno della propria tesi in gurppi di discussione, comunicare concetti giuridici in forma scritta ed orale;
- l'abilità di porre in essere analisi e ragionamenti giuridici.

The course aims at providing students with the following abilities:

- A comprehensive understanding of the principles established by the European Convention on Human Rights with regard on the Crimina Law matters;
- A knowledge of the function of the European Court of Human Rights;
- The ability to analyze the case-law of European Court of Human Rights;
- The ability to argue for a thesis during group discussions and to communicate legal concepts orally and in writing;
- The ability to perform competent legal analysis and reasoning.



## Modalità di valutazione dell'apprendimento e prova d'esame:

Alla fine del percorso gli studenti che avranno frequentato più dell'80% delle lezioni dovranno affrontare un colloquio con il titolare e gli assistenti prevalentemente sui temi trattati durante il corso, nonchè su parte del programma il cui materiale verrà fornito dal docente (upload su questo sito). Per gli studenti non frequentanti è previsto il superamento di una prova orale avente ad oggetto il programma il cui materiale verrà fornito dal docente (caricato su questo sito).

At the end of the course students who have attended more than 80% of the lessons will have to face an interview with the owner and assistants mainly on the topics covered during the course, as well as part of the program whose material will be provided by the teacher. Students who do not attend classes are required to pass an oral exam concerning the program whose material will be provided by the teacher (uploaded on this website).

### A chi è rivolto il corso:

Il corso "European Court of Human Rights: the application of criminal law principles" è rivolto agli studenti della laurea magistrale in Cooperazione internazione e sviluppo che abbiano intenzione di approfondire la delicata tematica della tutela dei principi sanciti dalla Carta Europea dei Diritti dell'Uomo, con particolare riferimento all'ambito penale e alla tutela delle libertà individuali. Il corso sarà pertanto volto a rendere edotti i discenti sull'origine e sul funzionamento della Corte EDU, rivolgendo particolare attenzione agli articoli della Carta volti alla tutela dell'individuo in sede penale e alle statuizioni della Corte che meglio rappresentano il precipitato della applicazione "vivente" dei principi codificati dal Consiglio d'Europa. Il corso sarà tenuto in lingua inglese, ma gli studenti non verranno privati di interagire in lingua italiana con la docenza durante le lezioni.

The course "European Court of Human Rights: the application of criminal law principles" is aimed at students of the Master's Degree in International Cooperation and Development who intend to deepen the issue of the protection of the principles enshrined in the European Convention of Human Rights, with particular attention to the criminal law and to the protection of individual liberties. The course will therefore aim to educate learners about the origin and functioning of the ECHR, paying particular attention to the articles of the Convention aimed at protecting the people in relation with criminal matters and the Court's decisions that best represent the the "living" application of the principles established by the Council of Europe. The course will be held in English, but the students will be allowed to interact in Italian with the teacher during the lessons.

Ad ogni modo, non è richiesta una impeccabile padronanza della lingua inglese, in quanto il corso vuole essere un'opportunità per gli studenti di implementare le proprie capacità in punto di lingua giuridica.

The teaching method is based on lectures and discussions between the students and the teacher, mainly addressing the materials (judgments, legal acts, articles) previously provided to the students. Anyway, a perfect command of English is not needed for the purposes of this course, which is also meant as an opportunity for students to enhance their linguistic skills in legal issues.

## Cooperation and social democracy

Numero di crediti :6 Semestre : 2° semestre Docenti: Paolo Borioni

Collaboratori: Pierluigi Marinucci - Domenico Romano

### Obiettivi formativi:

The aim of the course is providing the students with a good knowledge of social democracy as an international actor and factor in the XX century, especially concerning how it tried to render its model of society (a socialist but gradual and democratic reform of capitalism) coherent with international Cooperation. The chronological context will be the XX century especially its second half, and the present post-cold war transformations.

A direct knowledge of specific projects, problems and innovations in the field of international Cooperation will also be provided, especially through the contact with international institutions, experts and scholars

### Contenuto e articolazione del corso:

Syllabus:

First week: definition of the course and of Social democracy as an international actor Second week further definition of social democratic social and political model Texts for the first two weeks

Several PP slides and some text among which "Democratic socialism means solidarity" by Swedish Sap (1972); "World peace, super powers and national independence" by O. Palme (1978);

Third week: Introduction to Moyn, Not enough. Further discussions and texts concerning Social democracy socio-political models and social democracy as an international actor.

Presentations of students' assignments in class possible from now on

Texts:

Reading of the last chapter/conclusions in Moyn; several papers and documents such as "The new programme of the Spö", Austrian social democracy (1978); Olof Palme lecture at Harvard University on Full Emoloyment (1984)

Fourth to fifth week: analysis and reading of "The social construction of Swedish neutrality" Texts: Agius, The social construction of Swedish neutrality

April: Every week will be devoted to further reading/discussions of Moyn (one day) and Willy Brandt and International Relations: Europe, the USA and Latin America, 1974-1992 (second day) Besides: presentations and discussions in class.

Additional lessons by Dr. P. Marinucci (the political philosophy of Human rights in Moyn's text); Dr. D. Romano, Willy Brandt and the North-Sputh commission.

Texts: B. Rother, K. Larres, Willy Brandt and International Relations: Europe, the USA and Latin America, 1974-1992; S. Moyn, Not enough; D. Thorsdeniya, Swedish development aid in post 1977 Sri Lanka; C. Marklund, Double loyalties?, Small-state solidarity in the Debates on New Internation Economic Order in Sweden during the long 1970ies.

In the course of the month and until the end of the course special lectures will also be provided during the lessons and/or debates among experts will be provided. Confirmed so far: Friedrich Ebert foundation on German social democratic cooperation;

Further proposals concerning the course can be discussed and considered.

Final test: a written (strongly reccommended but non-mandatory) text in class, last day (choice of three questions out of five provided, resulting in 3 medium texts (about 400 words each) to be written in 2 hours time)



First result communicated to the students: good, fair, to be improved

Oral exam: discussion of the written test to begin with the first available slot in Infostud system.

Final grade: combination of the result from the written test (weighed 50%) and the oral exam (weighed 40%). Activity and presentation in class also included in the final grade (weighed 10%)

Oral exam for students not taking the written exam: all the mandatory texts

Oral exam for students not attending class courses: one compulsory extra text to be agreed (see for example below)

Modalità di valutazione dell'apprendimento e prova d'esame:

A non-mandatory written final test will consist of two Hours and five questions among which they will have to choose three. Answers will have to be around 300-400 words. The written test will take place at the end of the course and won't be compulsory, nonetheless, having taken the test with positive outcome will imply a positive impact in final grading. Moreover, having taken the written test will imply a shortened oral test.

The oral test will be compulsory for all students, and will take place later. This test will consist of a discursive check of the written test for the students who took the written test. Only in case of unconvincing response the oral test will last as long as for the students not having taken the written test.

- In both tests students will have to include the single research assignments carried out during the course

The methodological procedure reccomended for every test and assignment will be the following:

- 1) Periodization:
- a) Chronological frame
- b) Conceptual frame (why we choose some events or social relations as the beginning and end of a certain period/chain of events/transformations)
- 2) Concise reconstruction of facts, social relations main problems and/or changes or personalities) within this certain frame
- a) Concise reconstruction of causes and effects of the observed phenomena
- 3) Analysis: further and deeper evaluation of the cause/effects in the observed phenomena
- a) Opinion

## Theories and policies of economic development in the modern world system

Settore scientifico disciplinare: Secs P/04

Numero di crediti :6 Semestre : 2° semestre Docenti: Edvige Bilotti

### Obiettivi formativi:

L'obiettivo del corso è ripensare le teorie e le politiche dello sviluppo economico nel sistema capitalistico. Il corso fornirà agli studenti gli strumenti analitici per comprendere le dinamiche economiche, politiche, sociali nel contesto della globalizzazione in una prospettiva sistemica e interdisciplinare, di lungo periodo e su larga scala.

The object of the course is to rethink theories and policies of economic development in the capitalist world system. The course will provide analytical tools to understand economic, political, social dynamics in the context of globalization through a systemic, interdisciplinary, long-term, large scale perspective.

Contenuto e articolazione del corso:

Il corso propone di offrire un panorama critico delle correnti di pensiero sullo sviluppo economico e coprirà tre aree principali:

1. Teorie dello sviluppo economico

Ripensare le teorie dello sviluppo economico dagli anni quaranta ad oggi in una prospettiva sistemica e interdisciplinare, globale e di lungo periodo. In particolare saranno esaminati: il consenso keynesiano e il progetto nazionale di sviluppo; il consenso di Washington e il progetto globale basato sul neoliberismo; i paradigmi alternativi.

2. Politiche economiche di sviluppo

Rassegna critica delle politiche economiche. In particolare: la tradizione di economia politica, ancorata al sistema teorico neoclassico, affermata in seguito alla cosiddetta "rivoluzione conservatrice"; una seconda tradizione che vede lo sviluppo come un processo in cui si combinano più dimensioni sociali e politiche, istituzionali e ambientali.

3. Ruolo e attività delle Organizzazioni Non Governative (ONG)

Centralità delle Ong nelle teorie e pratiche dello sviluppo. Attuazione di politiche di sviluppo, progetti di solidarietà sociale e di equità, lotta alla povertà, difesa dei diritti umani e attività umanitarie. Saranno coinvolti esperti esterni di cooperazione internazionale e di Ong.

The course offers a critical survey of currents of thought on economic development and will cover three main areas:

1.Theories of Economic Development

Rethinking theories of economic development from the 1940s to today, from a perspective which is systemic and interdisciplinary, global and long-term. In this context, the following subjects in particular will be discussed: the Keynesian Consensus and the national project of development (late 1940s to early 1970s); the Washington Consensus and the global project based on neoliberalism (1980s to today); alternative paradigms.

2. Economic Policies of Development

Critical review of economic policies. In particular: the tradition of political economy, anchored to the neoclassical theoretical framework, which became popular following the so-called "conservative revolution"; a second tradition which looks at development as a process in which different factors - social, political, institutional, environmental- are combined.

3. Roles and Activities of Non-Governmental Organizations (NGOs)



Centrality of NGOs in theories and practices of development. Implementation of: development policies, projects of social solidarity and of equity, war on poverty, defense of human rights, humanitarian activities. Visiting experts representing such organizations will also lead classes.

Conoscenze e competenze che saranno acquisite:

Il corso fornirà una capacità analitica e interpretativa per comprendere la complessità delle dinamiche economiche, politiche, sociali nel contesto della globalizzazione in una prospettiva sistemica e interdisciplinare, di lungo periodo e su larga scala.

The course will provide an analytical and interpretative understanding of the complexity of economic, political, social dynamics in the context of globalization through a systemic, interdisciplinary, long-term, large scale perspective.

Prerequisiti ed eventuali propedeuticità: Nessun prerequisito specifico è richiesto

Modalità di valutazione dell'apprendimento e prova d'esame:

Gli studenti frequentanti sono tenuti a studiare il materiale bibliografico durante il corso. La loro preparazione sarà valutata sulla base di brevi presentazioni, di un'attiva partecipazione nella discussione in classe e di un esame finale orale.

Keeping up with the required readings is essential. Students who attend classes, will be assessed on the basis of the following: 1) brief oral presentations 2) participation in class discussions 3) final oral examination.

Gli studenti non frequentanti dovranno sostenere l'esame orale studiando tutti i testi in programma per i frequentanti a cui aggiungere alcuni saggi da concordare con la prof.ssa Bilotti.

## Laboratory on EU Cooperation Project Designing for cooperatives in development (3 cfu)

### Obiettivi formativi:

This Laboratory is aimed at providing to the future practitioners of the international development cooperation the competences needed to make use of the cooperative business model in the international development interventions, with particular reference to the interventions funded by the financial instruments of the European Union.

#### Contenuto e articolazione del corso:

The Laboratory is mainly structured in practical working sessions involving the students in analysing and reporting cases of international development cooperation initiatives that supported the creation or the development of cooperative enterprises.

The Laboratory will cover the following subjects:

The Cooperative enterprise: principles, values, governance and legislation;

The Contribution of the cooperative enterprises for the attainment of the Sustainable Development Goals in DCs and LDCs;

The Italian, European and International Cooperative Movement;

Analysis of cases of International Development Cooperation projects that adopted the cooperative model;

Main features of the EU Programmes and Calls for Proposals for external action;

Analysis of European Union Call for Proposals;

Project elements and Project Cycle Management;

Project designing tools and forms (Application Form, Logical Framework, Budget, etc)

The Laboratory will be in English.

The course will be held every Tuesday from 10 to 12 at the Aula Portico in Via Salaria 113starting from Tuesday 10th March 2020. The total duration of the course is 24 hours.

## Jean Monnet Chair - EU Trade Policy for Development

Settore scientifico disciplinare: SECS-P/02

Numero di crediti :9 Semestre : 2° semestre Docenti: Pierluigi Montalbano

#### Obiettivi formativi:

The Course aims at providing students with the following achievements:

Knowledge and understanding: students acquire advanced knowledge on the theoretical and applied linkages between international trade, trade policies and economic performance and living conditions in developing countries. This knowledge includes full understanding of the distinction between long and short-run trends, including regional variations, as well as the impacts of the major policy shifts which have taken place over the last four decades on the living conditions in developing countries;

Applying knowledge and understanding: students will be equipped with the tools necessary to practice as a working economist, especially as they apply to the problems of low-income countries. These tools include an applied understanding of key economic concepts, the ability to work with and interpret economic models, the understanding of the most relevant contemporary debates in development (e.g., trade and poverty, trade and vulnerability, trade and food security; trade and GVCs; aid effectiveness, etc.), the theoretical underpinnings of the different positions, and their policy implications;

Critical skills: students will be able to understand the most relevant economic models as well as to retrieve and make sense of available empirical data to interpret contemporaneous phenomena by making appropriate reference to the main economic models on trade and development;

Communication skills: students will be involved in in-class activities and presentations meant to strengthen their ability to present arguments and information on the topic in both written and verbal form. Students should be able to summarise and present the main points from a mass of data, to highlight and present in a cogent manner the main issues in debates, and to be able to clearly present, selecting and applying appropriate theoretical models;

Learning skills: students learning abilities include the capacity to keep track of the most relevant contemporary debates by becoming familiar with the appropriate sources for different information (included the most relevant scientific journals in the field) as well as to collect and interpret data on developing countries making reference to the main sources and typologies of data available at the international level.

Contenuto e articolazione del corso:

The course is articulated in three different modules:

The first module (24h) (Lectures L1-L8) is devoted to the basic notions of the most important theoretical and technical background about trade policy. It will provide appropriate knowledge on the main concepts, indicators and instruments of trade policy, such as: openness in practice vs openness in policy; aggregation and policy equivalence of measures of trade restrictiveness; relative trade preferences; non-tariff barriers and their measurement issues; trade-related policy issues; trade facilitation; etc..

The second module (24h) introduces the students to the EU trade policy for development, such as: its evolution over time; multilateral negotiations; preferential vs non preferential agreements; regional and intra-regional development agreements; the Economic Partnership Agreements; the Euro-Med



free trade area; the European Neighborhood Policy; the Everything but arms initiative, the EU Policy Coherence for Development, etc..

The third module (24h) focuses on some selected challenges for the EU Trade and development agenda, such as the new patterns of vertical integration and global value chains; firms' heterogeneity; the global imbalances and the role of emerging economies; the preference erosion of developing countries; the stalemate of multilateral and bilateral negotiations; climate change, poverty traps and vulnerability to trade openness; trade policy and food and nutrition security; inclusive growth and social innovation, etc..

Conoscenze e competenze che saranno acquisite:

The Course aims at providing students with the following achievements:

Knowledge and understanding: students acquire advanced knowledge on the theoretical and applied linkages between international trade, trade policies and economic performance and living conditions in developing countries. Learning skills: students learning abilities include the capacity to keep track of the most relevant contemporary debates by becoming familiar with the appropriate sources for different information (included the most relevant scientific journals in the field) as well as to collect and interpret data on developing countries making reference to the main sources and typologies of data available at the international level.

To pass the exam, students should undertake a written test, possibly supplemented by an oral interview

The written exam will last 45' and is in the form of 20 multiple choices' tests. This written test could be supplemented by an oral interview of one of the topics included in the programme of the course. Students pass the exams with a grade not less than 18/30. This shows a sufficient knowledge and understanding of the key topics of the course.



To pass the exam with first-class honor they should demonstrate excellent knowledge and understanding of all the topics of the course. Summa cum laude can be awarded for distinguished students that show qualified achievements during the course as well as the ability to link the various topics of the course in a logical framework.

Attending students can make in-class presentations to be separately evaluated. They can decide whether this mid-term evaluation should be included in the final mark.

Because of the coronavirus emergency, exams for the summer term AY 2019-20 will be managed online via the Exam.net platform: https://exam.net/. Students are kindly asked to register to that platform in advance.

Students should be also registered to the Sapienza e-learning Platform: https://elearning.uniroma1.it.

To be admitted to the exam, students should book in advance via infostud.

During the exam, students should connect using a smartphone through the Google Meet platform (a free web application, available in the Google Educational Suite) using the google ID available on infostud. This latter will be activated only on the day and time of the exam.

During the exam, participants should turn on both videos and microphones to keep constant interactions with the supervisors.

Frontal lectures are the key in fixing students' background knowledge and understanding on the key topics in the field (i.e., the hard skills).

Readings of the original seminal papers contribute in fostering both students' critical and learning skills by becoming familiar with the most relevant scientific articles and journals in the field as well as to develop a critical view in interpreting data, methods and appropriate theoretical methods and make judgments about how secure are the different outcomes.

Presentations and open debates are specifically meant to foster students' communication skills.

## European Union Law and Human Rights

Settore scientifico disciplinare: IUS/14

Numero di crediti :9 Semestre : 1° semestre Docenti: Alessandra Mignolli

### Obiettivi formativi:

This is a specialized course on European Union Law. Its goal is to provide students with an advanced knowledge of the European legal system of the Union, while focusing on specific parts of the external action of the Union. It will allow students to be aware of the legal mechanisms and means of action of the Union in the fields of its competence, to handle EU legal materials, to understand the dynamics of EU institutions. The focus on human rights and sustainable development is instrumental in addressing one of the most important features of the EU's external policies, while highlighting and discussing successes and shortcomings of the EU's approach to the matter. The course's final objective is to stimulate critical thinking on the basis of knowledge, through the involvement of students in discussions and specific researches that can be presented in class during the course.

Contenuto e articolazione del corso:

The course is articulated in two parts.

The first part of the course covers the European Union legal order:

- 1. The evolution of the European integration process.
- 2. The enlargement process
- 3. The Treaties
- 4. The institutions of the EU
- 5. The system of judicial review. Enforcement of EU Law
- 6. The sources of EU Law: primary Law, EU legislation, international agreements
- 7. The competences of the EU: exclusive and shared
- 8. The principles governing the competences: conferral, subsidiarity, proportionality
- 9. The relations between European law and domestic law: supremacy and direct effect
- 10. Introduction to the single market: the fundamental freedoms, the EU policies. The Area of freedom, security and justice
- 11. The EU's external action: CFSP and other areas of external action

The second part of the course is devoted to the role of human rights and sustainable development in the external policies of the EU, with particular regard to the common commercial policy:

- 1. Sustainable development in the framework of the objectives of the EU
- 2. The EU common commercial policy and the multilateral system of the WTO
- 3. International trade and developing countries. The Generalized System of Preferences. The EU's GSP and the human rights and sustainability clauses. The mechanisms of conditionality.
- 4. International trade as an instrument for the fight against torture and the death penalty. The EU regulation on torture and death penalty goods.
- 5. Trade in conflict diamonds and minerals. Between trade regulations and corporate social responsibility. The mechanism of due diligence in the supply chain.
- 6. The sustainable use of natural resources and EU trade regulation: the cases of seal products, timber products, illegal, undocumented and unregulated fishing, and the sustainability criteria for biofuels.
- 7. Problems arising from the unilateral regulation of trade for sustainability objectives. The controversial issue of extraterritorial reach of unilateral trade measures adopted by the EU.

### Conoscenze e competenze che saranno acquisite:

As apecified before, the course will provide advanced knowledge on the European Union's legal system, institutions and competences, with a specific focus on the Union's external policies for the promotion of human rights and sustainable development in third countries.



## Modalità di valutazione dell'apprendimento e prova d'esame:

The progression of learning will be evaluated all along the course, through the daily discussions in class and the presentations. The final exam is written, and consists in a few (from three to four) open questions to be answered synthetically by the students in the time frame of one hour.

### A chi è rivolto il corso:

The course is addressed to first year students of the Master course in Economics for Development, the English curriculum of the laurea magistrale in Scienze dello Sviluppo e della Cooperazione internazionale, to Erasmus students and students of the laurea magistrale who can choose this course as part of their own curriculum.

### Come ottenere la tesi:

I am available as thesis supervisors. Who is interested should discuss it with me during office hours. Please be aware that I require at least six months to write the dissertation, so don't ask me a thesis if you don't have that kind of time. You are welcome to submit a research proposal, and on the basis of your proposal we will agree on the title of the thiesis.

### Metodi didattici:

The course will follow a mixed teaching method. This means that there will be traditional lectures, but students will be involved at all stages of the course. I will give assignments and students will be required to do their own research and present it in class. Some important developments and policy issues in the EU's current historical moment will require our constant attention, and that will be done though the commitment of groups of students to follow the developments and report weekly in class (only to mention the most discussed issues: Brexit, the inauguration of the new Commission, the approach to migration policy and to environmental policy).

# Modalità di valutazione della frequenza:

Attendancy will not be monitored, as attending is not mandatory. Nevertheless, non attending students are not allowed to participate in the presentations, and are non allowed to participate in mid-term evaluations, as this requires being present in class and involved in the collective work of the class group at all times. It comes down to the individual responsibility of all of you to respect this rule of conduct, so please abstain from requesting me to make a presentation or be inserted in a presentation group if you are a non attending student.

## Population and Development

Settore scientifico disciplinare: SECS-S/04

Numero di crediti :9 Semestre : 2° semestre

Docenti: Maria Rita Testa - Marina Zannella

#### Obiettivi formativi:

The main aim of the course is to overwiev the causes and consequences of population change in historical and comparative perspective and to gain an understanding of their interrelation with the main underlying economic and social dynamics.

## Contenuto e articolazione del corso:

Introduction: In 2015 world population reached 7.3 billion by adding approximately one billion people in the last twelve years. Despite the pace of growth is slowing down, global population is projected to increase by more than one billion people within the next 15 years. Globally, life expectancy rose by 3 years between 2000 to 2015, that is from 67 to 70 years. The literacy rate among youth aged 15 to 24 has increased globally from 83 per cent to 91 per cent between 1990 and 2015. Although significant achievements have been made, progress has been uneven: the world is still demographically divided and major gaps exist also at the country-level between people belonging to different sex, income groups and ethnicities.

Contents: This course offers an overview of population and development studies and their interplay. The main focus of the course is on causes and consequences of population change. After discussing the internationalization of population and development policies during XX and XXI century, the course focuses on key demographic topics including: history of global population change, demographic perspectives and theories, demographic processes (mortality, fertility, migration), human capital and future of the world population.

### States and minorities in the international dimension

Settore scientifico disciplinare: SPS/06

Semestre: 2° semestre

## Obiettivi formativi:

The course will provide a wide and multidisciplinary vision of the relationships between international institutions and States in the contemporary age. During a first phase, particular attention will be devoted to the impact of the Enlightenment and the development of the idea of the nation, which would soon lead to the gradual decline of multinational empires and the consolidation of national states. In a second section, the course will focus on East-Central Europe analyzing the international dimension of the relationships between States and minorities, with the aim of understanding how the inter-ethnic complexity of this region has influenced the system of international relations during the twentieth century. The East/West division, in fact, could contribute to describe an interesting unified framework within which each country and each area, while following the path of the entire continent, expresses its own particular identity. The goal is to provide the basic knowledge in order to continue and deepen the study of history of international relations and of the multilevel governance dynamics among international and sovranational institutions, States and local and regional dimensions.

# Contenuto e articolazione del corso:

The classes will begin with an introduction on the study of nationalism and the creation of national States in order to present the situation of national and ethnic minorities in the historical passage between nineteenth and twentieth centuries. The main part of the course will be devoted to the study of international protection of minorities, its functioning, its decline and the birth of the new perspective concerning human rights. The course will be carried out through the traditional classes and will include a special focus on a case study that will be chosen by the student with the help and assistance of the professor. This case study will be presented at the final exam.

## Conoscenze e competenze che saranno acquisite:

The course will analyze the relationships between the States and the different ethnic groups - hence, between majorities and minorities, dominant and dominated groups - and their implications the international dimension through the study of international law and international protection of minorities. A special attention will be devoted to the system created after the first world war and during the contemporary age, for example concerning the protection of minorities and refugees up to the definition of the crimes against humanity.

# Prerequisiti ed eventuali propedeuticità:

The only prequisite is a basic knowledge of European and International history in nineteenth and twentieh centuries

# Modalità di valutazione dell'apprendimento e prova d'esame:

The exam will be carried out through verbal examination and will include the subjects of the classes and the the discussion of the case study chosen by the student. The evaluation will take in consideration both language fluency and abilities of summarizing and analyzing events in their complexity.
