1. Stages of the procedure

To be admitted to the degree programme, it is necessary to:

- a. **Pay** the €10 fee following the methods and deadlines laid down in paragraph 3.
- b. **Wait for the result** of the entry requirements assessment. **If the requirements are not met**, missing credits (ECTS) can be acquired by passing single courses. Methods and costs are laid down in Article 41 of the Student Regulations.

- c. **Carry out the academic knowledge assessment** in compliance with the procedures laid down in paragraph 4.
- d. **Proceed to enrolment** by paying the degree programme tuition fees following the procedures and deadlines laid down in paragraph 5. Enrolment can be carried out only after the Student Affairs Office sends the email informing about the successful result of the entry requirements and academic knowledge assessment.

Graduand candidates

Should the Programme Regulations allow it, students from Sapienza University of Rome or from other Italian universities who have not graduated yet can also apply for the entry requirements assessment, subject to the obligation of gaining their degree by January 13,

2024 (for Sapienza University of Rome graduands) and by December 16, 2023 (for graduands coming from other Italian or international universities).

Candidates coming from foreign countries

Procedures for international candidates are indicated in paragraph 6.

2. Admission requirements

To be admitted to the master's degree in Environmental and Sustainable Building Engineering, a three-year bachelor's degree or academic diploma or other international educational qualification, deemed appropriate, ascribable to a three-year degree in architecture, civil or building engineering is necessary; it is also required to hold a B2 level English language certificate.

It is also required to meet the curricular and academic knowledge requirements, that entail adequate mastery of the preparatory knowledge and methods consistent with the master's degree programme. The curricular requirements for admission to the master's degree programme are:

bachelor's degree in classes 4 or 8 (Ministerial Decree 509/99), L23 or L7 (Ministerial Decree 270/04);

Having acquired credits (ECTS) as specified below:

At least 25 ECTS in the following Scientific-Disciplinary Sectors (SSD) FIS/01, GEO/05, MAT/05, MAT/07, ICAR/17, ICAR/18, at least 40 ECTS in the following SSD ICAR/10, ICAR/11, ICAR/12, ICAR/14, ICAR/20, ICAR/21, ICAR/22, MED/42, at least 20 ECTS in the following SSD ICAR/06, ICAR/07, ICAR/08, ICAR/09 at least 20 ECTS in the following SSD ICAR/01, ICAR/02, ICAR/03, ING-IND/11 making an overall total of 105 ECTS.

3. Entry requirements assessment

The entry requirements assessment is requested by paying a €10 fee within one of the following dates, chosen by the student:

- September 14, 2023 (only date available for non-EU students applying for a student visa)
- October 16, 2023
- November 16, 2023
- December 14, 2023
- January 16, 2024 (date available only for Sapienza University graduands and graduates).

The payment is generated on the Infostud system.

The **payment** must be carried out online with PagoPA (direct payment).

The **code** to insert on the system is **30842**.

The result of the entry requirements assessment will be given on the candidate's institutional email address (if activated) or on the candidate's personal email address given on Infostud.

4. Academic knowledge assessment

The adequacy of academic knowledge is assessed through an interview and the evaluation of the study plan carried out in the bachelor's degree. The criteria and procedures for this assessment are defined in the Programme Regulations. A good command of the English language is also required, both in written and spoken form; since the programme is delivered in English, a proficiency of no less than the B2 level of the Common European Framework of Reference for Languages (CEFR) is required.

A certified B2 level of both spoken and written English is required.

English language proficiency may also be recognised if a B2 language activity has been completed in the bachelor's degree or through attendance of advanced language courses provided by the Faculty and the successful completion of the relevant test before enrolment.

The methods for the academic knowledge assessment, which is only open to students meeting the curricular requirements, are set out in the Programme Regulations, available on the degree programme's website.
