## ESTABLISH

### Art. 1 Research Project

A public selection procedure to award n. 1 post-doctoral position (**category B - Type II**) to perform research activities for a duration of 24 months within the disciplinary scientific sector M-PSI/01 in relation to the research project "**The attentional curve of forgetting visual information in younger and older adults: experimental and computational insights**" supervised by Dr. Moreno I. Coco, at the Department of Psychology of the University of Rome "La Sapienza". The award will be attributed on the basis of merits as evidenced by the curriculum vitae of the candidate and assessed through an interview.

### Art. 2 Duration, renewal and monetary compensation for the position

The research position referred to in Art. 1 shall have a duration of 24 months and may be renewed, pursuant to Art. 22, paragraph 3 of Law 240/2010.

The overall duration established, pursuant to Article 22, paragraph 3 of Law 240/2010, including possible renewals, cannot in any case exceed six years, excluding the period in which the position may coincide with the pursuing of a PhD program, up to the maximum of its legal duration.

The total duration of the relationship established with the holder of the research grant and researchers on fixed-term contracts hired under such a grant, as referred to in Article 24 of Law 240/2010, cannot exceed twelve years, even if not continuous. For the purpose of the duration of the aforesaid relationship, periods spent on maternity leave or leave for health reasons in accordance with the regulations in force are not relevant.

The gross amount of the allowance is set at **€29,000.00 (twenty-nine thousand/00 euros)** gross payable by the beneficiary to the post-doctoral researcher hired under the research grant in monthly installments.

The provisions of Article 4 of Law No 476 of 13 August 1984, as subsequently amended and supplemented, and those of Article 2(26) et seq. of Law No 335 of 8 August 1995, as subsequently amended, shall apply to the allowances in matters of taxation, as well as those of Article 2(26) et seq. 335 of 8 August 1995 and subsequent amendments, in the matter of compulsory maternity leave, the provisions of the Decree of the Minister of Labour and Social Security of 12 July 2007 and, in the matter of sick leave, Article 1, paragraph 788, of Law no. 296 of 27 December 2006 and subsequent amendments.

The Department guarantees equality and equal opportunities between men and women for the allocation of the allowances in question and protect confidentiality in the processing of personal data, in accordance with the provisions in force.

### Art. 3 General admission requirements

Eligibility for admission to the selection process is to hold a PhD (PostDoc) degree in Psychology or related disciplines, directly or indirectly connected to it (e.g. Cognitive Science, Neuroscience of Behaviour, Computer Science) or an equivalent qualification, including those obtained abroad. Researchers with a more advanced curriculum, including those who have obtained academic positions in foreign universities, research organizations, public or private research institutions, limited to non-tenured positions in Italy, are also eligible. Tenured personnel of the subjects referred to in Art. 22, paragraph 1 of Law 240/2010 is not eligible to this call.

Those who have a degree of kinship or affinity, up to the fourth degree inclusive, with a professor belonging to the Department of Psychology or with the Rector, the Director General or a member of the University Board of Directors may not participate in the selection process.

Research positions cannot be awarded to:

- individuals who are in a situation, even potential, of conflict of interest with "La Sapienza" University
- individuals who have been convicted, even if the sentence is not final, of one of the offences referred to in Chapter I of Title II of Book II of the Penal Code and/or for offences for which mandatory arrest in "flagrante delicto" is envisaged pursuant to Article 380 of the Code of Criminal Procedure
- in all other cases provided for by law.

Foreign citizens must hold a qualification recognized as equivalent on the basis of international agreements, or in accordance with the procedures laid down by the relevant legislation in force. This equivalency must be proven by appropriate certification issued by the competent authorities.

Qualifications obtained abroad that have not already been declared equivalent, in accordance with the legislation in force, will be evaluated solely for the purposes of the selection procedure by the selection committee board.

The requirements must be met by the deadline for the submission of applications for admission to this selection for the candidate to be eligible.

#### **Art. 4 Application and submission deadline**

The application to take part in the selection process must be done by compiling the annexed forms (**Annex A**) that could be found at the end of this document and sent, **within 30 days from the day after publication (see the expiry date indicated on the initial page of the notice)**. Candidates will be excluded by the selection process if they do not follow one of these two methods to send their documentation:

It should also be noted that this Department will not be held responsible in the event of the computer support being unreadable or damaged.

The **subject of the e-mail/postal mail** of the application must state exactly the following: "**Concorso per Assegno di Ricerca - Bando Prot. N. 2036/2023 del 13-09-2023**".

Should the deadline fall on a public holiday, it will be postponed to the first working day. In the application form, candidates must indicate a personal e-mail address to which all communications must be sent, including communications for the interview. Any eventual change about their situation must be promptly communicated to the Department of Psychology.

The Department does not accept any responsibility if the candidate is unavailable or for any lack of communication due to failure, late or inaccurate communication about the candidate's e-mail address indicated in their application.

Applicants are in any case required to consult the University website at <http://web.uniroma1.it/transparency/albo-pretorio>, which will be faithfully report all updates, acts and information concerning the specific selection procedure.

In the application (Annex A) applicants must declare, under their own responsibility, and pending a possible exclusion from from the selection procedure:

- surname and first name
- date and place of birth; residence
- nationality held;
- enjoyment of political rights;

- not to have not been convicted of any criminal offenses and not currently undergoing criminal or administrative proceedings for the application of security or preventive measures, nor to have a criminal record pursuant to art. 686 of the Code of Criminal Procedure;
- university degrees held, with an indication of the mark awarded, as well as the date and university where it was obtained;
- equivalence of qualifications, if obtained abroad/Declaration of the value of qualifications obtained abroad that have not already been declared equivalent;
- to possess the title of PhD in ..... or the following equivalent title ..... also obtained abroad, or that he/she is a researcher with a more advanced curriculum also having obtained the following structured position(s) in foreign or, limited to non-tenured positions, Italian universities, research organizations, public or private applied research institutions (specifying which).
- whether the candidate has held research grants with the indication of the location, the period in which the activity was carried out and the subject of the research;
- whether the candidate has held fixed-term researcher contracts, pursuant to art. 24 of Law no. 240 of 30 December 2010, with indication of the location, the period in which the activity was carried out and the subject of the research
- that he/she is not the holder of any other scholarship for any reason whatsoever awarded or that he/she will relinquish such a scholarship if he/she passes this selection procedure
- whether the candidate is carrying out any other work activity at .... (specify employer, whether public or private body and type of relationship)
- that the candidate does not have a degree of kinship or affinity, up to and including the fourth degree, with a professor belonging to the Department of Psychology, or with the Rector, the Director General or a member of the Board of Directors of the University of Rome "La Sapienza
- that the candidate has not been dismissed or discharged from employment with a public administration for persistent, inadequate performance and that the candidate has not been debarred from a state job, pursuant to art. 127, first paragraph, letter d), of the Consolidated Text of the provisions concerning the status of civil employees of the State, approved by Presidential Decree no. 3 of 10 January 1957
- the personal e-mail address to which you wish to receive communications relating to this selection procedure.



Candidates with disabilities, according to the Law no. 104 of 5 February 1992, must make an explicit request, in relation to their disability, concerning the aid they may require shall they choose to attend the interview in person.

## **Art. 5 Curriculum vitae and academic titles**

The following qualifications must be attached to the application in PDF format:

1. declaration of whether the candidate is currently enrolled into a PhD program (specifying if with or without scholarship) and/or whether the candidate has been contracted to carry out research activities (Attachment B);
2. declaration in lieu of certification of degrees (e.g., BSc or MSc) or other recognized diplomas, with date of achievement, mark and indication of marks obtained (Attachment C);
3. declaration in lieu of certification of Research Doctor (PhD), including those obtained abroad (Attachment C);
4. declaration in lieu of certification of work experience with public/private bodies;
5. declaration in lieu of certification or affidavit of qualifications that are deemed useful for the call (specialization diplomas, certificates of attendance at post-graduate specialization courses in Italy or abroad, scholarships or research assignments awarded both in Italy and abroad, etc.) (Attachment C);
6. curriculum vitae in European format of one's scientific and professional activity, dated and signed;
7. a list of scientific publications (Attachment D).
8. copy of a valid identity document, passport is preferred, or health card (front/back) dated and signed;
9. Two letters of reference (possibly one from the supervisor of the doctoral work, and one from the dissertation examiner or academic familiar with the candidate's work).

Pursuant to the amendments introduced by Article 15, paragraph 1, of Law No. 183 of 12 November 2011, to the regulations on certificates and declarations in lieu of certification contained in Presidential Decree No. 445/2000, Public Administrations may no longer request or accept certificates containing information already in the possession of the P.A.. Therefore, only declarations in lieu of certification and/or affidavit submitted pursuant to Articles 46 and 47 of Presidential Decree 445/2000 will be admitted and considered valid.

With reference to publications, which are considered useful for the purposes of this selection procedure, candidates must also enclose a declaration in lieu of affidavit certifying their conformity to the original (pursuant to art. 47 of D.P.R. 445/2000) (Attachment D).

Titles written in a foreign language must be accompanied by a translation into Italian, which must be certified as conforming to the text by the competent authorities. Exception is placed for publications and titles certified in the English language.

Foreign citizens residing in Italy may use substitute declarations limited to cases in which it is a matter of proving states, facts and personal qualities that can be certified or attested to by public or private Italian bodies.

## **Art. 6 Selection procedure**

The evaluation criteria shall be determined by the Commission and expressed in hundredths and include, with appropriate weights, the following items:

- Degrees and their grades (if not evaluated in a pass/fail scale)
- Publications in international, indexed (DOI) journals in fields relevant to this call, and other research products, such as dissemination in international conferences, organization of workshop, etc.;
- Postgraduate diplomas and certificates of attendance at postgraduate courses;
- Titles related to the activity carried out as holders of contracts, scholarships and appointments in national or international research organizations (start and duration of such activities must be duly attested)
- Curriculum Vitae indicating the candidate's academic career, including any publications, research activities and experience, presentations at conferences, etc.
- Two letters of reference (one from the supervisor of the doctoral work, one from the examiner of the doctoral thesis or academic familiar with the candidate's work)
- In-depth knowledge of eye movements (eye-tracking)
- Advanced knowledge of inferential statistics (e.g., linear-mixed models, Bayesian regressions, etc.) and experience in longitudinal research
- Advanced programming knowledge in at least one of the following languages (R, Python, Matlab, Julia or C++)
- Excellent knowledge of the English language, certified if possible
- Interview

### **Art. 7 Interview**

The examination consists of an interview to be held in English and focused on the research project referred to in Art. 1 of this notice, in particular candidates will be assessed on their:

- Knowledge of human cognitive neuroscience with a focus on theories, methods and models of visual attention, long-term memory and forgetting
- Longitudinal experimental methodologies and advanced inferential statistics
- Computer Programming
- Discussion of all qualifications declared in their curriculum vitae

**The interview will take place at the Department of Psychology - Via dei Marsi n.78, Cap. 00185, Rome, on 25/10/2023 at 14:30.**

The interview may be also conducted remotely.

This notice describes the objectives of the interview and no other communication will be provided regarding it.

Applicants must be in possession of a valid identity document to attend the interview. During the interview, the selection board will check the candidate's ability to deal with the topics covered by the examination.

The interview will take place in a classroom and open to the public. At the end of each session, the selection board will publish the results obtained by the individual candidates.

**Art. 8**  
**Examination Committee**

The Commission is appointed by the Director of the Department, on a proposal approved by the Board or, in cases of urgency, by the Department Council, if terms have expired.

The Commission is composed of three members: a full professor acting as Chairman and two members chosen among professors and researchers (including those on fixed-term contracts) of La Sapienza University and researchers of Research Institutions in agreement; one of them will also act as the secretary and so take the minutes of the selection.

All members of the commission must belong to the competition sector or disciplinary scientific sector that is the subject of the selection.

The Commission's judgment is final.

The Commission may avail itself of the services of highly qualified Italian or foreign auditors from outside the University at no additional cost to the public finance.

**Art. 9**  
**Formation of the merit list**

The Commission, at its first meeting, establishes the criteria and methods for evaluating the qualifications and the interview, and formalize them in the relative minutes to assign the relative scores to the candidates.

The Commission, on the basis of the scores awarded, will form the merit list in descending order, adding together the scores for the qualifications, the publications and the interview.

The Director of the Department, having verified the administrative-managerial regularity of the selection procedure by the Delegated Administrative Officer, approves the results of the selection process, which will be published at the Department and on the University website, notifying the candidates, whom have the opportunity to take up their duties within 30 days from the date of the communication by e-mail, starting from the first candidate in the ranking list and then proceeding in the ranking order, if the selected candidate renounces the offer by written communication.

Candidates who do not declare their acceptance of the post-doctoral position or who do not communicated anything by the deadline set by the call for applications will automatically loose the right to the offer.

Only deferments of the starting date of the grant due to duly certified health reasons, compulsory maternity leave and duly substantiated cases of "force majeure" can be justified.



## **Art 10** **Award of post-doctoral position**

The post-doctoral position is awarded by means of a private law contract. This contract does not in any way constitute a subordinate employment relationship and does not give any right of access to the University staff.

The winner must produce within 30 days of the award, under penalty of forfeiture of the right to the same, a declaration on plain paper, in accordance with art. 46 of DPR 28.12.2000, no. 445, indicating

- a. date and place of birth
- b. citizenship;
- c. enjoyment of political rights
- d. absence of criminal convictions and pending criminal proceedings.

Declarations to points c) and d) must indicate that the candidate meets all requirements relative to expiry date of the deadline for submitting applications.

The successful candidate will be required to provide a declaration in lieu of affidavit as to the authenticity of the qualifications presented. Failing the issue of such a declaration, he/she will be required to submit the qualifications assessed in original, or alternatively, to duly regularize them.

It is the right of Administration to verify the truthfulness and authenticity of the certificates produced. In the event of false declarations, the provisions of Articles 75 and 76 of Presidential Decree no. 445 of 28.12.2000 shall apply.

Pursuant to Article 15 of Legislative Decree no. 33 of 14 March 2013, the winner must submit to the Department of Psychology:

- a. a version of their curriculum vitae, ensuring that it complies with the requirements of European Regulation No. 679/2016 and Article 26 of Legislative Decree No. 33 of 14 March 2013, for the purpose of publication, and marking that such curriculum vitae can be used "for the purpose of publication"
- b. data relating to the performance of appointments or the holding of offices in bodies governed by private law or financed by the public administration or the performance of professional activities.

The submission of the documents referred to in points a) and b) is a condition for the contract to become effective and for the payment of the relevant fees.

At the time of taking up the assignment, the Director of the Department shall indicate to the assignee the name of the Scientific Coordinator to whom he/she is assigned.

The winner must also comply with the requirements of the University Regulations for the awarding of the post-doctoral position. The winner will be provided with a copy of the said Regulations.

## **Art. 11**





## **Rights and duties**

Post-doctoral researchers must carry out their research activities within the framework of the research program approved by the Department to which they belong; the tasks assigned to them must relate to research activities and not merely be of a technical support nature. Post-doctoral researchers may collaborate in research activities carried out by students for the preparation of their dissertations; they may participate in seminars and tutorials for students and sit on the committees of profit examinations as experts in the subject.

Post-doctoral researchers have the right to use, for the purposes of carrying out their research activities, the facilities of the Department where they perform their services and to use the services available to researchers in accordance with the rules in force and the provisions approved by the Department. If, where expressly authorized by the Head of Science, the research fellow has to go on a mission as part of the research to which he/she is assigned, he/she will be reimbursed for his/her expenses according to the criteria and procedures in force.

Post-doctoral researchers are required to submit to the management of the Department an annual written report on the research activity carried out accompanied by the assessment of their Scientific Director.

Part of the research activity may be carried out at a University or Research Institution abroad, obtaining specific certification, provided that this is consistent with the program and objectives of the research entrusted to the post-doctoral researcher; the period of stay abroad must be expressly authorized in advance by the Department to which the post-doctoral researchers belong to, on the basis of a reasoned proposal by the Scientific Director.

Post-doctoral researchers accept and undertake to observe and comply with all the provisions of the Code of Ethics, the Code of Conduct for public employees adopted by Decree of the President of the Republic no. 62 of 16 April 2013, the Code of Conduct for employees of Sapienza University issued by R.D. no. 1528 of 27/05/2015 and the University Code of Ethics issued by R.D. 1636 prot. 0032773 of 23/05/2012. Violation by the assignee of the obligations deriving from the Code of Conduct for Public Employees shall be considered a serious breach and shall result in the termination of the contract pursuant to Article 1456 of the Italian Civil Code and Article 2, paragraph 3 of Presidential Decree no. 62/2013.

Post-doctoral researchers required to comply with the protection and safety regulations, including health, in force at this University.

### **Art 12**

#### **Prohibition of accumulation, incompatibility, suspension**

Post-doctoral positions may not be summed to a gross annual personal income from employment, pursuant to art. 49, paragraph 2 of the TUIR - Title I, Chapter IV, exceeding €16,000.00.

The post-doctoral positions cannot be accumulated with other scholarships for any reason whatsoever, with the exception of those granted by national or foreign institutions useful for integrating the research activity of the holders of the scholarship during stays abroad.

Post-doctoral positions may not participate in degree courses, specialised or master's degrees, PhD courses with scholarships, in Italy or abroad.

Employees in the service of public administrations who hold a research grant must be placed on unpaid leave.

An employee of a private employer, even if part-time, may not receive a post-doctoral position. The post-doctoral position cannot be accumulated with other research grants, even if awarded by state, non-state or other remote bodies, as well as by the bodies referred to in Article 22(1) of Law no. 240/2010.

The post-doctoral position is granted on an individual basis; they may be self-employed, subject to written notification to the Department to which they belong and on condition that this activity is declared by the Department to be compatible with the research activity, does not entail any conflict of interest with the specific research activity carried out by the holder, and does not prejudice the University, in relation to the activities carried out; the Scientific Director and the post-doctoral position must declare that they are not bound by any current or preexisting professional relationship.

Post-doctoral researchers who intend to carry out, or continue to carry out, a work activity involving services free of charge at voluntary associations or cooperatives or non-profit cultural institutions or non-profit social welfare institutions, may do so, provided that they fully discharge their research duties.

The research activity of the post-doctoral researcher is suspended in cases of compulsory maternity leave, parental leave and sick leave and extended in accordance with the regulations in force. A total period of justified absence not exceeding thirty days in a year does not constitute suspension.

### **Art. 13 Withdrawal and termination of the relationship**

Against the post-doctoral researcher who, after starting the planned research activity, does not continue it for the entire period, regularly and uninterruptedly, without justified reason, or who is responsible for serious and repeated failures or non-compliance, the procedure to declare the termination of the contract is initiated, upon a reasoned proposal from the Scientific Director, approved by the Council of the relevant Department.

The reasons for termination of the relationship are the following:

- unjustified failure to start the activity or delay its actual start;
- unjustified suspension of activity for a period that is detrimental to the research program;
- violation of the incompatibility regime established by art. 6 of the Regulation, reiterated after an initial notice;
- negative opinion expressed by the Council of the relevant Department or by the administration and management body of the same Department.

In the event of withdrawal post-doctoral researcher, they must communicate this via certified email to [DIP.PSICOLOGIA@CERT.UNIROMA1.IT](mailto:DIP.PSICOLOGIA@CERT.UNIROMA1.IT)

### **Art. 14 Publication of the selection procedure and final rules**

The notice relating to this selective procedure will be published on the website of the Department of Psychology on the University Transparency portal, on the M.U.R. website, and the European Union.

The personal data provided by candidates with the application will be only processed for the purposes of managing the selection procedure and any potentially following recruitment procedure.

At any time, interested parties may exercise the rights referred to in European Regulation no. 679/2016. The person responsible for processing personal data is the Process Manager.

For anything not provided for in this announcement, reference is made to the relevant legislative and regulatory provisions in force.
