Having regard to Law 9.5.1989, n. 168;
Having regard to Law 30 December 2010, n. 240 and in particular art. 22;
Having regard to the Statute of the University issued with D.R. n. 3689 of 29/10/2012;
Having regard to D.R. n. 1549/2019 of 15/05/2019 with which the amendment of the Statute of this University was ordered;
Having regard to the Regulation for the awarding of research grants issued with D.R. n. 427/2021 prot. n. 0011083 of 11/02/2021;

Having regard to the Ministerial Decree no. 102 of 09.03.2011 with which the minimum gross annual amount of research grants announced pursuant to Law 240/2010 is determined in a sum equal to € 19,367.00 net of charges borne by the administration;
Having regard to the request of prof. Sergio Marchisio and Raffaele Cadin responsible for the HABITABLE project (H2020): Linking Climate Change, Habitability and Social Tipping Points: Scenarios for Climate Migration;
Considering the resolution of the Council of the Department of 20.12.2022 with which the publication of the call in question was approved;

Art. 1 (Research project)

A public selection procedure is announced, based on qualifications and interview, for the assignment of **n 1 grant for the performance of category B Type II research activities** lasting 1 year, research project "Legal and policy practices and options on adaptation measures to the adverse effects of climate change: fostering solutions and promoting best practices to address major climate-migration challenges", for the scientific disciplinary sector **IUS/13**, related to the HABITABLE project (H2020): Linking Climate Change, Habitability and

Art. 2

(Duration, renewal, and amount of the allowance)

The research grant referred to in art. 1 will have a duration of 1 year and may be renewed, in accordance with the provisions of art. 22, paragraph 3 of Law 240/2010.

The total duration of the relationships established, pursuant to art. 22 paragraph 3 of Law 240/2010, including any renewals, cannot in any case exceed six years, with the exception of the period in which the grant was used to coincide with the PhD, within the maximum limit of the legal duration of the related course.

The total duration of the relationships established with the holders of research grants and fixed-term research contracts pursuant to art. 24 of Law 240/2010, stipulated with the same subject, cannot in any case exceed twelve years, even if not continuous. For the purposes of the duration of the aforementioned relationships, periods spent on maternity leave or for health reasons according to current legislation are not taken into account.

The gross annual amount is established at € 19,367.00 in (in letters nineteen thousand three hundred and sixty-seven / 00) gross of the charges borne by the beneficiary and will be paid in monthly installments.

In tax matters, the provisions of art. 4 of Law no. 476 of 13 August 1984 and subsequent amendments and additions, as well as, in social security matters, those referred to in art. 2, paragraphs 26 and following, of Law 8 August 1995, n. 335 and subsequent amendments, on compulsory maternity leave, the provisions of the Decree of the Minister of Labor and Social Security 12 July 2007 and on sick leave, art. 1, paragraph 788, of Law no. 296 of 27 December 2006 and subsequent amendments.

The Department guarantees equality and equal opportunities between men and women for the allocation of the allowances in question and the protection of the confidentiality of the processing of personal data, according to the provisions in force.

Art. 3

(General admission requirements)

Those who hold the title of PhD (PostDoc) in the scientific disciplinary sector SSD IUS / 13 or equivalent, also obtained abroad or researchers with a more advanced curriculum also for having obtained structured positions in universities, research institutions, applied research institutions, public or private, foreign or, limited to non-tenured positions, can participate in the selection, Italian, with the exception of tenured staff of the subjects referred to in art. 22, paragraph 1, of Law 240/2010.

Those who have a degree of kinship or affinity, up to and including the fourth degree, with a professor belonging to the Department of Political Science or with the Rector, the Director General or a member of the Board of Directors of the University cannot participate in the selection.

Research grants cannot be awarded to:



- subjects who are in a situation, even potential, of conflict of interest with the University "La Sapienza";
- subjects who have been convicted, even with a sentence that has not become final, for one of the crimes provided for in Chapter I of Title II of the second book of the Criminal Code and / or for crimes for which mandatory arrest in flagrante delicto is provided for pursuant to art. 380 c.p.p.;
- in all other cases provided for by law.

Foreign citizens must be in possession of a qualification recognized as equivalent according to international agreements, or in the manner provided for by current legislation on the subject. This equivalence must result from appropriate certification issued by the competent authorities. Qualifications obtained abroad that have not already been declared equivalent, in accordance with current legislation, will be evaluated solely for the purpose of selection, by the jury; To this end, they must be translated, legalized and provided with the declaration of value by the competent Italian diplomatic representations abroad, and attached to the application, also in photocopy.

The requirements must be met on the expiry date of the deadline for submitting applications for admission to this selection.

Art. 4

(Application and deadline for submission)

The application for participation in the selection, drawn up on plain paper according to the attached diagram (Annex A), **must be sent, within thirty days from the day following publication**, to the following certified e-mail address: dirdipscienzepolitiche@cert.uniroma1.it

If the deadline falls on a public holiday, the deadline is postponed to the first working day.

In the application form, candidates must indicate a personal e-mail address to which any communication should be sent, including communications for any interview. Any changes must be promptly communicated to the Department of Political Science

The Department assumes no responsibility in case of unavailability of the recipient and for dispersion of communications dependent on failure, late or incorrect communication by the candidate of the e-mail address indicated in the application.

In the application, competitors must declare, under their own responsibility, under penalty of exclusion from the selection procedure:

- surname and first name;
- date and place of birth;
- residence;
- Citizenship possessed;
- enjoyment of political rights;
- not to have reported criminal convictions and not to have ongoing criminal and



administrative proceedings for the application of security or prevention measures, nor to have a criminal record that can be entered in the criminal record pursuant to art. 686 of the CPP;

- degree possessed with the indication of the grade reported, as well as the date and the University at which it was obtained;
- equivalence of qualifications, if obtained abroad/Declaration of value of qualifications obtained abroad that have not already been declared equivalent;
- to possess the title of PhD or the following equivalent qualification, also obtained abroad or to be a researcher with a more advanced curriculum also for having obtained the following position / s structured in universities, research institutions, applied research institutions, public or private, foreign or, limited to non-tenured positions, Italian (specify which);
- any holding of previous research grants indicating the location, the period in which the activity took place and the subject of the research;
- any previous ownership of a fixed-term researcher contract, pursuant to art. 24 of Law no. 240 of 30 December 2010 with an indication of the location and period in which the research activity took place;
- not to be holders of other scholarships for any reason conferred or to undertake to renounce them in case of passing this selection procedure;
- to carry out the following work activity at..... (specify employer, whether public or private entity and type of relationship).....
- not to have a degree of kinship or affinity, up to and including the fourth degree, with a professor belonging to the Department of Political Science, or with the Rector, the General Manager or a member of the Board of Directors of the University of Rome "La Sapienza";
- not to have been dismissed or dismissed from employment with a public administration for persistent, insufficient performance and not to have been declared forfeited from a state employment, pursuant to art. 127, first paragraph, letter d), of the consolidated text of the provisions concerning the statute of civil servants of the State, approved by Decree of the President of the Republic 10 January 1957, n. 3;
- the personal e-mail address, to which you would like communications relating to this selection procedure to be sent.

Candidates with disabilities, pursuant to Law no. 104 of 5 February 1992, must make an explicit request, in relation to their disability, regarding the necessary aid to be able to take the interview.

Art.5 (Titles and professional curriculum)

The following titles in pdf format must be attached to the application:

1. substitutive declaration of certification pursuant to art. 46 of the D.P.R. 28 December 2000, n. 445 of the degree diploma with the indication of the marks reported in the individual exams and in the degree exam, of the University that issued it and of the year of achievement;



2. substitutive declaration of certification pursuant to art. 46 of Presidential Decree no. 445 of 28 December 2000 of any PhD or equivalent title also obtained abroad or for the sectors concerned of the title of specialization in the medical area accompanied by an adequate scientific production;
3. substitutive declaration of certification or deed of notoriety pursuant to art. 46 and 47 of Presidential Decree no. 445 of 28 December 2000 of the qualifications that are considered useful for the purposes of the competition (specialization diplomas, certificates of attendance of post-graduate specialization courses obtained in Italy or abroad, study stays abroad, scholarships or research assignments both in Italy and abroad, degree or doctoral theses, etc.);
4. curriculum of his scientific and professional activity;
5. any scientific publications;
6. copy of a valid identity document.

Pursuant to the amendments introduced by art. 15, paragraph 1, of Law no. 183 of 12 November 2011, to the discipline of certificates and substitute declarations contained in Presidential Decree 445/2000, Public Administrations can no longer request or accept deeds or certificates containing information already in the possession of the P.A. Therefore, only substitutive declarations of certification and / or deed of notoriety presented pursuant to art. 46 and 47 of Presidential Decree 445/2000.

With reference to the publications, which are considered useful for the purposes of this selection procedure, candidates must also attach a specific declaration in lieu of the deed of notoriety certifying its conformity with the original, pursuant to art. 47 of Presidential Decree 445/2000.

Titles written in a foreign language must be accompanied by an Italian translation, which must be certified in conformity with the text by the competent authorities. Translation of publications and titles written in English is not required.

Foreign citizens residing in Italy can use substitute declarations limited to cases in which they are to prove states, facts and personal qualities certifiable or attestable by Italian public or private subjects.

Foreign citizens not resident in Italy cannot avail themselves in any way of the institution of self-certification.

Art. 6 (Selection)

The evaluation criteria shall be determined by the Commission, shall be expressed in cents and shall include, with appropriate weights, the following items:

- PhD in the scientific-disciplinary sector IUS / 13 or related sectors;
- Graduation mark;
- Publications and other research outputs;
- Specialization diplomas and certificates of attendance at post-graduate specialization courses;



- Other qualifications related to the activity carried out as holders of contracts, scholarships and positions in national or international research institutions. The start and duration of the activity must be duly certified;
- Documented knowledge of the English language;
- Colloquy.

The results of the evaluation of the qualifications will be made known to the interested parties by posting on the Register of the Department concerned and on the website of the same, before any interview is carried out.

Art. 7 (Interview)

Candidates admitted to the interview will be notified at least twenty days before the date on which they will have to take the test itself by notice sent to the competitors to the e-mail address they entered in the application form, unless all interested parties renounce in writing.

The Administration is not responsible for the change of e-mail address or its incorrect indication in the application form.

The interview can be carried out electronically.

To take the interview, candidates must have a valid identification document.

During the interview, the Examining Board will verify the candidate's knowledge of the topics covered by the proposed research project and the aptitude skills required (orientation to the results to be achieved; operational efficiency; ability to work in a team).

The interview will take place in a classroom open to the public. At the end of each session, the Selection Board shall make public the results obtained by the individual candidates.

Art. 8 (Examining Board)

The Commission is appointed by the Director of the Department, by resolution of the Council or, in urgent cases, of the Department Committee, once the deadlines have expired.

The Commission is composed of three members: a full professor with the function of President and two members chosen from among the professors and researchers (also fixed-term) of Sapienza and researchers of research institutions in agreement; one of them also has the function of Verbalizing Secretary.

All Commissioners must belong to the competition sector or to the scientific disciplinary sector subject to the selection.

The Commission's judgment is unquestionable on the merits.

Art. 9 (Formation of the merit ranking)

The Commission, at its first meeting, establishes the criteria and methods for evaluating the qualifications and any interview, formalizing them in the relative minutes, in order to assign the relative scores.



The Commission, on the basis of the scores awarded, forms the merit ranking in descending order, for each of the areas concerned, adding the score of the titles, publications and that of the possible interview.

The Director of the Department, after verifying the aspects relating to the administrative-managerial regularity of the selection procedure, by the Delegated Administrative Manager, approves with his own disposition the results of the selection which will be advertised at the Department and on the University website, giving notice to the competitors and giving rise to the taking of service that must take place within 30 (thirty) days from the communication by mail electronics, starting from the first in the ranking and then proceeding in the order of ranking where there is written renunciation.

The right to the research grant is forfeited by those who, within the deadline set by the announcement, do not declare to accept it or do not present themselves within the established deadlines.

Only deferrals from the date on which entitlement to entitlement to the allowance commenced due to duly certified health reasons, compulsory maternity leave and duly substantiated cases of force majeure may be justified.

Art. 10 (Awarding of research grants)

The cheque is awarded by private law contract. This contract does not in any way constitute an employment relationship and does not give rise to rights regarding access to the roles of the University's staff.

The winner must produce within 30 days from the delivery of the check, under penalty of forfeiture of the right to the same, a declaration in free paper, pursuant to art. 46 of Presidential Decree 28.12.2000, n. 445, from which it results:

- (a) date and place of birth;
- (b) nationality;
- (c) enjoyment of political rights;
- (d) non-existence of criminal convictions and ongoing criminal proceedings;

The declaration relating to points (b) and (c) must indicate that the requirement is met also on the date of expiry of the deadline for submitting applications.

The winner will be required to issue a substitutive declaration of notoriety about the authenticity of the titles submitted. In the absence of such a declaration, it will be required to present the certificates valued in original, or alternatively, to regularize them in stamp duty.

The Administration has the right to verify the truthfulness and authenticity of the certificates produced. In case of false declaration, the provisions of Articles. 75 and 76 of Presidential Decree 28.12.2000, n. 445.

Pursuant to art. 15 of Legislative Decree no. 33 of 14 March 2013, the winner must submit to the Department of Political Science: a) a version of his curriculum vitae, drawn up in such a way as to ensure its compliance with the provisions of European Regulation no. 679/ 2016 and art. 26 of Legislative Decree no. 33 of 14 March 2013, for the purpose of publication, and marking that resume for destination "for publication"; b) data relating to the performance of assignments or the holding of offices in private law entities regulated or financed by the public administration or the performance of professional activities. The presentation of the



documentation referred to in letters a) and b) is a condition for the acquisition of effectiveness of the contract and for the settlement of the related fees.

Upon taking up service, the Director of the Department indicates to the research fellow the name of the Scientific Director to whom he is entrusted.

The winner must also comply with the obligations provided for by the University Regulations for the awarding of research grants. A copy of the aforementioned Rules will be provided to the winner.

Art. 11 (Rights and obligations)

Research fellows must carry out their research activities within the research programs approved by the Department to which they belong; The tasks assigned to research fellows must relate to research activities and not merely provide technical support. Research fellows can collaborate in the research activities conducted by students for the preparation of the degree thesis; They can participate in seminars and exercises for students and be part of the exam boards as experts in the subject.

Research fellows have the right to use, for the purpose of carrying out their research activities, the equipment of the Department where they carry out their service and use the services available to researchers according to the rules in force and the provisions approved by the Department.

If, where expressly authorized by the Scientific Manager, the research fellow must go on a mission in the field of research to which he is attached, he will be reimbursed the expenses with criteria and methods according to current legislation.

Research fellows are required to submit annually to the management of the Department in which they carry out their activities a written report on the research activity carried out, accompanied by the evaluation of the Scientific Manager.

The research activity can be partly carried out at a University or Research Institute abroad, obtaining specific certification, provided that this is consistent with the programs and objectives of the research entrusted to the research fellows; the period of stay abroad must be previously and expressly authorized by the Department of affiliation on the motivated proposal of the Scientific Manager.

The research fellow accepts and undertakes to observe and comply with all the provisions of the Code of Ethics, the Code of Conduct for public employees adopted by Decree of the President of the Republic 16 April 2013, n. 62 and the Code of conduct for Sapienza employees issued by D.R. n. 1528 of 27/05/2015. The violation by the grant holder of the obligations deriving from the Code of Conduct for public employees will be considered as a serious breach and will result in the termination of the contract pursuant to art. 1456 c.c. and art. 2, paragraph 3, of Presidential Decree no. 62/2013.

The research fellow is required to comply with the rules of protection and safety, also in the health field, in force at this University.

Art. 12 (Prohibition of cumulation, incompatibility, suspension)



Research grants cannot be combined with a gross annual taxable income of employees, pursuant to art. 49, paragraph 2 of the TUIR title I, chapter IV, exceeding € 16,000.00.

The grants cannot be combined with scholarships for any reason awarded, with the exception of those granted by national or foreign institutions useful to integrate, in the context of stays abroad, the research activity of the scholarship holders.

Holders of research grants cannot participate in Bachelor's Degree, Master's or Master's Degree Courses, PhD with scholarship or medical specialization, in Italy or abroad.

The employee in service with Public Administrations holder of the research grant must be placed on leave without checks.

The employee of a private employer, even if part-time, cannot benefit from research grants.

The research grant cannot be combined with other research grants, even if conferred by different universities, state, non-state or telematic, as well as by the bodies referred to in art. 22, paragraph 1, of Law no. 240/2010.

The allowance is individual; grant holders may carry out self-employment activities, subject to written communication to the Department to which they belong and provided that this activity is declared by the Department itself compatible with the exercise of the research activity, does not involve conflicts of interest with the specific research activity carried out by the grant holder, does not prejudice the University, in relation to the activities carried out; the Scientific Manager and the holder of the grant must declare that they are not linked by current or pre-existing professional relationships.

Holders of grants who intend to carry out or continue to carry out a work activity involving services rendered free of charge in voluntary associations or cooperatives or non-profit cultural institutions or non-profit social welfare institutions, may carry it out, without prejudice to the full performance of their research tasks.

The research activity of the research fellow is suspended in cases of compulsory maternity leave, parental leave and sick leave and extended according to current regulations. A total period of justified absence not exceeding thirty days in a year shall not constitute suspension.

Art. 13

(Forfeiture and termination of the relationship)

With regard to the holder of the grant, who after starting the planned research activity does not continue it regularly and continuously for the entire period, without justified reason, or who is responsible for serious and repeated failures or defaults, the procedure is initiated to declare the termination of the contract, on a motivated proposal of the Scientific Manager, approved by the Council of the Department of reference.

The causes of termination of the relationship are as follows:

- unjustified failure to start the activity or delay in the actual start of the activity;
- unjustified suspension of activity for a period prejudicial to the research programme;
- violation of the regime of incompatibilities established by art. 6 of the Regulation, reiterated after an initial notice;
- negative opinion expressed by the Council of the Department of affiliation or by the restricted body of administration and management of the same Department.



Art. 14

(Publicity of the selection procedure and final rules)

The call for applications for this selection procedure will be published on the website of the Department of Political Science, on the University Transparency portal, on the M.I.U.R. and European Union website.

For anything not provided for in this announcement, reference is made to the current laws and regulations on the subject.

The personal data provided by candidates with the application form will be processed for the purposes of managing the selection procedure and any recruitment procedure.

At any time the interested parties may exercise the rights referred to in European Regulation no. 679/2016.

The person responsible for the processing of personal data is the Person in charge of the procedure.
