## ART. 1 LEGAL BASIS AND OBJECT OF THE PROGRAMME

The triple degree programme is an integrated curriculum course of study that includes an educational path designed with the foreign university and a period of mobility.

The selected student has the opportunity to receive a financial contribution and will attend a part of his or her career at the foreign university taking advantage of the services and facilities available and attending courses aimed at obtaining the Italian title and the foreign title of the same level without the payment of additional tuition fees<sup>(1)</sup>.

The opportunity offered by the triple degree programme is, first of all, to fit into an international context and, often, also into the world of work.

The faculty of Arts and Humanities of Sapienza university of Rome, the university of Tübingen and the University of Aix-Marseille have signed an agreement to establish a triple degree programme concerning the masters degree in Mediterranean Archaeology.

<sup>1</sup> Students who have won scholarships to non-EU/multiple degree countries are required to pay only the tuition fees to Sapienza University of Rome, which, however, is not responsible for any participation fees. The host university may ask additional fees.

### **ART. 3 REQUIREMENTS FOR PARTICIPATION AND ELIGIBILITY**

The present call is open for:

- Students enrolled in the last year of a three-year degree course in Archaeology or similar subjects (L-1 or L-43 degree classes) with the intention of enrolling (in line with the procedures and deadlines established by the student affairs office) in the Mediterranean Archaeology Masters Degree for the a.y. 2025/ 2026;

OR

- students who already possess a Bachelor's degree in Archaeology or similar subjects (L-1 or L-43 degree classes) and having completed the pre-inscription procedures for the Mediterranean Archaeology (LM-2) Masters degree;

OR

- students enrolled in the 1st year of the Mediterranean Archaeology degree.

In order to participate in the call for proposals you must meet the following requirements:

- be up to date with tuition fees;
- maintain the student status until the end of the study period abroad and not obtain the qualification before the recognition by the Academic Head of Mobility (RAM) of the educational activity carried out at the host university;
- possess adequate language skills required by the host University (proficiency of at least B2 in English);
- do not make use, contextually, of two different grants, for international exchanges or stay abroad (you can participate in several calls in the same academic year, if compatible with each other, but the period of study must be different. This scholarship cannot be cumulated with contributions paid by the "Scholarship for thesis abroad" programme);
- have obtained at least 169 credits in your bachelor's degree

### **ART. 4 SUBMISSION PROCEDURES**

Applicants may submit their application no later than 14.00 on 31 July 2025.

The application, filled in all its parts and signed, must be sent by e-mail at

CRISTINA.LEMORINI@UNIROMA1.IT, indicating in the subject line of the e-mail "Application for triple title in Palaeolithic Archaeology - Art-W Sapienza- Aix Marseille - Tübingen".

The following documents must be attached to the application form (Annex A):

- Valid ID card;
- Tax code;
- Certificate of the exams taken (printable from your personal area on Infostud, in the "Certificates" section); in case of University other than Sapienza attach a certificate of the exams taken issued by the student affairs office of the University of origin;

- Motivation letter (max 2 pages);
- updated CV, better if in EuroPass format;
- Any certifications attesting knowledge of the foreign language.

Failure to send the documents indicated in this call within the deadline stated, as well as the lack of truthfulness of the self-certified or declared information, will constitute grounds for exclusion.

## **ART. 5 COMPATIBILITY**

Students who have previously benefited from a non-EU mobility grant cannot be awarded a second grant with the same funds unless they are enrolled in subsequent cycles of their academic career.

It is not allowed to receive grants for international exchanges or stays abroad with Sapienza funds at the same time as the grant in question (it is possible to participate in several calls in the same academic year, if compatible with each other, but the study period must be different). This scholarship cannot be cumulated with contributions paid by the "Scholarship for thesis abroad" programme.

Candidates who have been awarded a triple degree mobility grant and who subsequently win an Erasmus+ grant for the same period of mobility must inform the offices of the International Office and the person in charge of the programme (contacts as per art. 8 and 16) which position they intend to give up, otherwise, they will be excluded from both.

## **ART. 6 SELECTION CRITERIA FOR THE ADMISSION TO THE TRIPLE TITLE AND RANKING PROGRAMME**

A commission, specially appointed by the President of the Board, composed of up to 5 Professors will evaluate the applications received by the deadline, following the conditions set out in this call, and will draw up a merit ranking based on the following criteria:

- academic career or the number of credits accrued/ average mark of your bachelor's degree; students who graduated with less than 100/110 or any equivalent will be disqualified;
- motivation letter (5 to 10 points);
- documents attached to the application (CV).

As a result of this assessment, the Commission will interview the candidates and verify their foreign language knowledge required by the host University Time and location of the interview will be emailed at the institutional address indicated in the application form.

You will be required to bring along your identity card. Failure to produce this document or to show it at the interview will constitute grounds for exclusion from the selection procedure.

In allocating mobility, with equal marks, priority will be given to the youngest students.

Based on the above criteria, the Commission will draw up a provisional ranking list which will be published at the link [https://web.uniroma1.it/trasparenza/bando/231375\\_306/2025](https://web.uniroma1.it/trasparenza/bando/231375_306/2025)

The ranking list will be considered definitive if no application for revision is submitted to the address [matteo.dipasquale@uniroma1.it](mailto:matteo.dipasquale@uniroma1.it) after ten consecutive natural days from the date of publication.

The selected candidates will be effectively admitted to the triple qualification programme under the following conditions:

- having obtained a bachelors degree in L-1 or L-43 degree classes
- be enrolled in the Masters Degree Course in Mediterranean Archaeology (LM-2) of Sapienza University of Rome according to the procedures and deadlines established by the administrative office.

The list of candidates selected by Sapienza University of Rome will be shared with University of Tübingen and the University of Aix-Marseille. The latter ones have the right to request further certifications, accept or reject the application.

The students admitted to the programme will spend the first semester at the University of Tübingen, the second semester at Sapienza University of Rome, the third semester at Aix-Marseille University and the fourth semester at one of the universities mentioned above, depending on their choice. To continue the triple degree programme and be admitted to the second semester at Sapienza, you must have acquired the 30 credits of the first semester at the University of Tübingen as set out in the curriculum of the triple degree programme annexed to this call for proposals (Annex 1).

## **ART. 7 PUBLICATION OF THE RESULTS**

The selected candidates will receive a letter of accreditation for the host university and must confirm in writing their acceptance of participation in the programme or refuse per art. 8 of this call.

## **ART. 8 ACCEPT TO PARTICIPATE IN THE PROGRAMME**

After ten days from the publication of the ranking, the winners must expressly accept or refuse participation in the triple title programme within the next seven natural and consecutive days by sending an e-mail to [cristina.lemorini@uniroma1.it](mailto:cristina.lemorini@uniroma1.it), indicating in the subject line of the e-mail "Acceptance/Rejection of triple title programme in Palaeolithic Archaeology - Art-W Sapienza- Aix Marseille - Tübingen".

Failure to comply with this deadline will be considered as renunciation.

In case of renouncement, the committee will proceed to assign the mobility to the next students in the ranking, who can then be contacted by e-mail/telephone and be invited to reply within two working days; otherwise, the mobility will be revoked.

The acceptance of mobility to other countries is a serious commitment made by the candidate. The assignees are invited to limit the waivers to serious and proven cases of force majeure, which must be promptly communicated in writing through the student's page, to allow the first candidate from the list of suitable candidates to take over in time for the organisation of the mobility period.

### **ART. 9 WAIVER OF MOBILITY**

Acceptance of the student mobility scholarship is a serious commitment made by the candidate. Winning students are invited to limit their waivers to serious and proven cases of force majeure, which must be promptly communicated in writing to the contacts referred to in art. 16 and in cc. [doubledegree.sapienza@uniroma1.it](mailto:doubledegree.sapienza@uniroma1.it) to allow the first available candidate to take their place, in time for the organisation of the mobility period.

Candidates who fail to communicate their resignation, or communicate their resignation late and whose resignation occurs after acceptance of the contribution, will be asked for the return of any share of the contribution already received.

The contribution for triple title mobility and the contribution for Erasmus in Europe cannot be cumulated for the same semester of mobility abroad. In case of withdrawal, the International Office, upon confirmation by the teacher responsible for the agreement, will proceed with the assignment of the mobility to the next students in the ranking who can then be called by e-mail and invited to reply within three working days; otherwise, the mobility will be revoked.

### **ART.10 STUDY PLAN**

Participating students must adhere to the curriculum of the triple degree programme which is approved by both institutions and is contained in appendix 1 and 2 of this call.

The list of courses may in part be subject to change if the educational offer should change.

Selected students are required to read and accept the content and rules of the curriculum.

The courses indicated must be supported and completed during the period of mobility and at the University indicated in the study plan. Failed examinations may be done again in the university where the course was taught, according to that same university's rules.

The exams taken will be recognised in the student career of both universities according to what established in the study plan of the triple degree.

### **ART. 11 THESIS AND TITLE**



The selected student will write his/her thesis according to the instructions of the supervisors of all universities and respecting the procedures and deadlines for the assignment of thesis indicated by the student affairs office.

The thesis will be discussed at Sapienza University of Rome. The thesis must be written in English, and a copy must be submitted to both institutions.

The final judgement will be expressed separately by both universities.

The student, in order to obtain the triple title, will have the opportunity to discuss the thesis no later than 31/07/2027

Upon completion of the programme, the following titles will be awarded:

- "Laurea Magistrale in Mediterranean Archaeology (LM-2)" issued by Sapienza University of Rome
- "Master of Science (MSc)" issued by the University of Tübingen
- "Master Sciences Humaines et Sociales – mention "Archéologie, sciences pour l'archéologie" issued by the University of Aix-Marseille

The degree will be awarded if the student has met the necessary criteria, i.e., has passed all the exams and obtained the credits provided for in the triple degree programme according to the times and methods established by the programme.

The selected student who has started the triple degree course and mobility but has not met the criteria provided for in the programme (either in progress or at the end of the programme) will be removed from the triple degree programme and will be reintegrated into the normal course of study at the home university.

## **ART. 12 COSTS**

For each academic year, students are required to register and pay fees at their home University. They are also required to register with the host University without paying any further fees and in accordance with the procedures of the host institution. However, the latter may request insurance and administrative expenses not covered by Sapienza University of Rome. Travel, accommodation and living expenses, and any other expenses incurred in the host country, are entirely borne by the students.

## **ART. 13 LOGISTICAL AND ORGANISATIONAL PROCEDURES FOR THE MOBILITY PERIOD**

Selected candidates will have to make their own arrangements:

- provide themselves with the necessary documentation for departure and required by the host country (passport, invitation letter or declaration from the host university, accommodation, etc.). -

provide themselves with adequate health cover during their stay abroad and, if necessary, take out suitable travel insurance following the terms of the host country.

Sapienza University of Rome does not assist or assume responsibility for the completion of the procedures mentioned above, which are the exclusive responsibility of the student.

Each winning student is insured by the University for civil liability and injuries only during the performance of academic activities also for the period of mobility abroad

[The above mentioned insurance covers only study and research activities and does not include the coverage of risks related to the exercise of the medical profession and health facilities. Therefore, students in the healthcare field will be responsible for finding such insurance independently].

## **ART. 14 SCHOLARSHIPS**

### **14.1 GENERAL ASPECTS**

Mobility grants are awarded exclusively for the academic activities carried out abroad and limited to the continuous period of mobility assigned.

To benefit from the grant, the student assigned to mobility must, before departure, sign the mobility contract and follow the instructions that will be provided when the mobility is assigned.

Students can benefit from the grant only once for each cycle of study.

The grant cannot be combined with other Sapienza grants (grants for thesis abroad, Erasmus+ grants or other mobility programmes), except for the grant for the right to study provided by Laziodisco.

The scholarship awarded on the basis of this call for proposals is a refund of part of the costs arising from the winning candidate's stay abroad, which will have to provide for all expenses, including those for visa, travel, food and accommodation and any fees for participation in international programs imposed by the host university, as well as any insurance policy for health expenses at the time of departure.

### **14.2 AMOUNT**

The scholarship is provided by the International Office- Non-EU Mobility Sector and International educational Agreements (ARI) and is € 700 per month net for the first five months of mobility. The amount for the months following the sixth is set at €500 net per month, as per BoD resolution no. 426/19 issued on 17.12.2019.

The award of the scholarship can be made only after the International Office has received the selection minutes with the names of the selected students, their email address and number, from the Commission in charge of the procedure.

The duration of the mobility cannot be less than three months (90 days) and not more than 12 months (2 consecutive semesters) or the maximum stay defined by the inter-university agreement and detailed at the time the mobility is assigned.

The scholarship will correspond to the actual and continuous duration of the mobility, attested by the arrival and departure certificates issued by the host university, the academic calendar of the host university and the transcript of records.

The letter of acceptance and the certificates of arrival and departure issued by the host university will be used as proof of the grant.

For durations of more than three months, the entire monthly contribution is recognised starting from the 16th day of stay at the host university.

No further monthly grant payments will be made if the duration of the scholarship is longer than the assigned mobility months.

For mobility of 1 semester per study (3, 4, 5 or 6 months), any extension of monthly payments may be granted but without contribution.

For mobility of 2 consecutive semesters, provided for by the bilateral agreement signed with the host university, the duration of the mobility must be at least nine months and 16 days. No contribution will be granted for mobility of seven, eight and nine months.

The following table summarises the contributions based on the length of mobility

Please note: If the grant allotted to the student is four months, the contribution will be 2800€. The minimum stay to obtain the total amount of the grant will be three months and 16 days.

#### 14.3 TAX TREATMENT OF THE CONTRIBUTION

According to art. 1, paragraph 50 of Law no. 208 of 28.12.2015, the exemptions provided for in art. 1, section 3 of Decree-Law no. 105 of 9 May 2003, converted with amendments, by Law no. 170 of 11 July 2003, apply to scholarships for international mobility unless further regulatory changes are made.

#### 14.4 TERMS AND CONDITIONS FOR THE GRANTING OF THE SCHOLARSHIP

The grant is paid according to the terms and conditions contained in the mobility contract that will be signed by the student and International Office- Non-EU Mobility Sector and International educational Agreements (ARI) and listed below:

##### ONE SEMESTER MOBILITY

The minimum stay must be 90 days (3 months), and the grant is paid out in 2 tranches:

- 70% of the total amount within 60 days of signing the contract as an advance payment of the contribution;
- 30% upon return, upon presentation and verification of the arrival and departure certificates available on the student's page and signed by the host university, confirming the actual period of mobility, in addition to the documentation required when assigning the mobility.

## TWO SEMESTER MOBILITY

In case of mobility of two consecutive semesters, the minimum stay must be ten months or nine months and 16 days.

The grant is paid out in 3 tranches as follows:

- 70% within 60 days from the signing of the above contract as an advance payment of the contribution;
- 70% upon completion of the first semester abroad, specifically in February or July, as an advance on the estimated duration for the second semester;
- 60% upon return, upon presentation and verification of the certificates of arrival, stay and departure available on the student's page and signed by the host university, confirming the actual period of mobility, in addition to the documentation required during the mobility assignment.

The final actual contribution (balance) will be calculated taking into account the dates reported on the arrival and departure certificates issued by the host University and in any case always in compliance with the maximum stay defined by the inter-university agreement and detailed when assigning the mobility.

The student will be entitled to the scholarship only afterwards:

- having received the letter of acceptance/invitation from the host University (sent directly to the student, to the contact person of the agreement or the International Office- Non-EU Mobility Sector and International educational Agreements (ARI)) and certifying a minimum acceptance period of 3 months (90 days);
- have filled in the Learning Agreement online and have received the RAM approval (art. 13.5);
- have signed the mobility agreement.

The signing of the contract and the completion of all the procedures required by the International Office- Non-EU Mobility Sector and International educational Agreements (ARI) must be completed within ten days before the actual departure, or the scholarship will be forfeited.

## 14.5 LEARNING AGREEMENT

According to the "Regulations for Student Mobility and Recognition of Study and Educational Period Abroad" (DR register no. 34218 - 13.05.2015) within the triple degree mobility program,

students of Sapienza have the opportunity to enjoy a mobility the outcomes of which are validated and transferred directly into their careers.

To this end, the selected student is required to fill in an official online study plan (Learning Agreement - LA) through his/her personal page by entering only the courses provided for in the triple degree study plan (appendix 1 of this call).

The Learning Agreement:

- is prepared before departure and only after confirmation of the grant award and its acceptance by the student;
- must be approved by the Academic Head of Mobility (RAM - list available here: <https://www.uniroma1.it/it/pagina/coordinatori-e-responsabili-accademici-mobilitainternazionale-0>).
- must be completed by the student in agreement with the Academic Manager of the agreement, the RAM and the host institution to guarantee the passing of the relative exams/tests abroad and the consequent recognition of the credits obtained;
- must provide for a minimum of 12 Sapienza exams to be recognized upon return. For the mobility of 2 consecutive semesters, the minimum number of CFU to be accepted upon return is 24 CFU.

Please note: The minimum number of credits for recognition is to be considered on the Sapienza exams inserted in the student's career and not on the number of credits of external exams that the student intends to acquire abroad.

The definition and consequent approval of the online LA are mandatory and binding for mobility and the granting of the scholarship, under penalty of exclusion of the mobility itself.

#### 14.6 COMPLIANCE OF THE DOCUMENTATION AND RETURN OF THE GRANT

The documentation relating to mobility will be subject to verification by the International Office. If the documentation mentioned above does not comply, the partial or total refund of the contributions paid will be required.

The return of the grant is for the student who:

- has not carried out (according to the agreed procedures) the planned educational course;
- has completed his/her mobility before the minimum 90 days;
- has received as the first instalment of the scholarship an amount higher than the total amount for the entire duration of the mobility. The actual length of the mobility will be attested by the certificate of arrival and departure (that can be found on the personal page of the selected candidate).
- belated communication of waiver or if it occurs after acceptance of the grant;
- the period of frequency is not continuous

The balance of the grant may not be paid to the student if he does not provide all the end of mobility documentation required by the International Office- Non-EU Mobility Sector and International educational Agreements (ARI) within the terms established in the mobility contract.

## **ART. 15 PROCEDURE SUPERVISOR**

In accordance with Law no. 241 of 7 August 1990, the person in charge of the procedure, for information and procedures of exclusive competence of Sapienza University of Rome, is Matteo Di Pasquale e-mail [matteo.dipasquale@uniroma1.it](mailto:matteo.dipasquale@uniroma1.it) Piazzale Aldo Moro 5, Building CU003.

## **ART. 16 CHECKS**

According to art.71 of DPR 445 - 28/12/2000, Sapienza University of Rome checks the truthfulness of self-certifications in accordance with current regulations and the incompatibility of the mobility grant in question with grants paid for other purposes, for international exchanges or stays abroad with Sapienza funds.

If the checks carried out on the individual information reveal a false declaration to allocate mobility grants abroad, the grant itself would be revoked and any sums already paid will be recovered, without prejudice to any criminal liability for any false declarations made.

This call for applications is published in English and Italian. In the event of conflicting interpretations between the two versions (ITA and EN), the only applicable text is the Italian version.

## **ART. 17 CONTACT INFORMATION**
