## PREAMBLE: THE ERASMUS + 2021-2027 PROGRAM

Mobility for study 2021/2022 will be governed by the legislation concerning the new seven-year period of the Erasmus program (2021/2027), the operational details of which are not yet known.

The activities and funding provided for in this Call are therefore subject to the definition of the programmatic guidelines by the European Commission as well as the relative signing of the Erasmus 2021/2022 financial agreement between the Erasmus National Agency and Sapienza University of Rome. Therefore, in case of discrepancy with the provisions of this call, the provisions of the new Erasmus 2021-27 program will prevail.

The guidelines of the new Erasmus Program could provide for mobility of different duration and typology compared to the previous program.

## **ART. 1 GENERAL INFORMATION**

### ART. 1.1 OBJECTIVES

The Erasmus+ programme for study allows university students to increase educational opportunities aimed at acquiring the necessary skills to favour their transition to the labour market. To this purpose Erasmus+ provides students with the opportunity of studying abroad up to a maximum total of 12 months per each cycle of study and 24 months for one-cycle study programmes, regardless of the number of mobility periods (i.e.: 2 periods of 6 months or 3 periods of 4 months).

The student selected for a mobility, obtains the status of Erasmus student, which entails rights and duties enshrined in the Erasmus Student Charter.

The student in Erasmus mobility receives a financial contribution, has the opportunity to follow courses and use the facilities available at the host institute without additional tuition fees (contributions to which local students are also subject may be required). The recognition in career of the activities supported abroad (with a positive outcome) provided that they are previously approved through the Learning Agreement / Change Form, is guaranteed by Sapienza with the approval of the Erasmus Policy Statement (EPS) and the Student Mobility Regulations and the recognition of a period of study and training abroad.

#### ART.1.2 PARTICIPATING COUNTRIES

For Academic Year 2021-2022, students may participate in the Erasmus+ Programme for Study at universities in European Union member states and other participating countries (Programme Countries).

The full list of possible destination countries is the following:

• Member States of the European Union: Austria, Belgium, Bulgaria, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Ireland, Latvia, Lithuania, Luxembourg, Malta, Netherlands, Poland, Portugal, Romania, Slovakia, Slovenia, Spain, Sweden and United Kingdom\*.

Following the Brexit Agreement, the British Government has decided to interrupt the UK's participation in the Erasmus + Program

 Non-EU Programme Countries: Iceland, Liechtenstein, Norway, Republic of North Macedonia, Serbia and Turkey.

#### ART. 1.4 MOBILITY TO SWITZERLAND

Switzerland <u>does not take part in the Erasmus+ Programme</u> under the same terms as Programme and Partner Countries; therefore, it **does not receive any EU funding** either for incoming or outgoing mobilities.

In order to guarantee existing mobility and cooperation, the Swiss Federal Council has developed a transitional solution, the so-called *Swiss European Mobility Programme* (SEMP). Under this programme, Swiss Universities finance the mobility of all incoming and outgoing students following the signature of specific agreements (see Art. 3. "Grants and Financial Benefits").





Students applying to Swiss universities must satisfy all the requirements described in this call (see Art. 2 "GENERAL APPLICATION REQUISITES AND ADMISSIBILITY").

## ART. 2 GENERAL REQUISITES FOR APPLICATION AND ADMISSIBILITY

#### ART. 2.1 GENERAL ADMISSION REQUIREMENTS

- 1. In order to apply to this call, students must be **enrolled full-time** at Sapienza for **Academic Year 2020/2021** in a Bachelor, Master, one-cycle or PhD degree programme,
- 2. Students must have adequate language skills (see Art. 2.4 "LANGUAGE REQUIREMENTS").
- 3. Students must complete their enrolment at Sapienza University for Academic Year 2021/2022 by the established deadlines (further information: <a href="https://www.uniroma1.it/it/pagina-strutturale/studenti">https://www.uniroma1.it/it/pagina-strutturale/studenti</a> "University Tuition"), except for undergraduates, pursuant to art. 13 of the study regulations.
- 4. Students enrolled in the academic year 2020/2021 in the third year or beyond of a Bachelor's Degree Course (I cycle) who plan to graduate by the end of the academic year, can apply for a mobility for the first year of a Master's Degree Course (II cycle), provided that mobility takes place exclusively in the second semester of the academic year 2021/2022. If the student applies for one year mobility, the same will be reduced as per practice. To take advantage of the mobility, students must enroll in a Master's Degree course for the academic year 2021/2022; in no case will it be allowed to anticipate departure for the first semester.
- 5. Students on an Erasmus mobility period **may not graduate** before the end of their period of study abroad and before the recognition of the academic activities conducted abroad by the Academic Coordinator of the Mobility Period (RAM), through the digitized validation procedure to be activated through the Erasmus personal page.
- 6. **Students enrolled in PhD Programmes** must end their mobility period before the official end of the Doctoral Programme and they must in any case obtain a certificate of the activity carried out by the host university.

#### ART. 2.2 INCOMPATIBILITY

Students applying to this call may receive one or more Erasmus+ mobility grants (Bachelor, Master, PhD) provided the total period does not exceed 12 months per each cycle.

This does not apply to mobility periods towards Switzerland which are regulated by the Swiss-European Mobility Programme (SEMP).

Prior mobility periods that have already been funded during the same study cycle under: ICM (International Credit Mobility), Lifelong Learning Programme, Erasmus+, Erasmus Mundus Action 1 and Erasmus Mundus Action 2 are included in the calculation of the total number of months spent abroad.

#### ART. 2.3 ACADEMIC REQUIREMENTS

- 1. In order to participate to the selection procedure it is sufficient to have acquired at least 6 CFU during the academic career.
- 2. During the selection process, all credits acquired after the application submission, obtained exclusively through exams and **officially registered on Infostud**, will be accepted for the selection process. Students may self-certify exams they have taken, but that have not yet been registered on Infostud, on their application at the closing of the call.





Self-certified exams will be checked.

Only the exams included in the study programme in which the student is enrolled can be self-certified. Therefore, **is forbidden** to self-certify:

- Exams taken during a previous cycle of studies (Bachelor) for students enrolled in a Master programme
- Single courses
- Extracurricular exams ex art. 6 of RD n.1269/38.

In case of false and mistaken self-certifications, a 100 points penalty will be applied on the academic merit score.

Please note: as per Art. 76 - D.P.R. 28.12.2000 N. 445 "... whoever provides false declarations, false acts or uses them for the purposes of the present call is passable of punishment as established by legislation and all special bills in this matter."

## ART. 2.4 LANGUAGE REQUIREMENTS

Before completing the on-line application form, each candidate must take the language test at the University Language Centre (Centro Linguistico di Ateneo – CLA). Students who satisfy the requisites described at Art. 2.4.3 on "LANGUAGE TEST EXEMPTIONS" do not have to take the language test.

The test will verify the language level of each student.

<u>PLEASE NOTE:</u> Students who have already taken the language test for the Erasmus + 2020-21 application, but who do not intend to use the exemption, can choose to take the test again. In this case, the new result obtained (lower, higher or failed test) will replace the previous one.

**Students applying** to the Call must have a minimum <u>A2 language level</u> Common European Framework of Reference <a href="https://www.coe.int/en/web/common-european-framework-reference-languages/level-descriptions">https://www.coe.int/en/web/common-european-framework-reference-languages/level-descriptions</a>.

The language test result, besides being an access requirement to the selection, will be element of evaluation for the purposes of the placement in the ranking (art.7.1)

In case of exemption from the language test (art.2.4.3), the documents uploaded in the online application will be submitted to evaluation.

PLEASE NOTE: the CLA test or the exemption according to the artr.2.4.3, does not exempt students from respecting the language requirements of the host University, which must be respected to enjoy the selected mobility period. In case that the host University requires a specific language certificate, the student must possess it before the departure (during the application at last). Therefore, in case of equal score, the chosen destination will be assigned to the student who has already uploaded the required language certificate in the application.

#### ART. 2.4.1 LANGUAGE TESTS

The tests, for the vehicular languages only, FRENCH, ENGLISH, PORTUGUESE, SPANISH, GERMAN, will be carried out by the CLA, in online mode, and the student must be in possession of a valid identification document (identity card, passport, driving license). Each student must book by choosing the date and time from the options present in the form available in the application, according to the following calendar:

## PLEASE NOTE: only available dates and shifts will be displayed on the application form.

The booking for the tests is to be considered confirmed only upon receipt of the notification e-mail on the institutional mailbox.

The student can take tests for a maximum of two languages on the basis of the locations selected in the application, necessarily on the same day, shift and time. It will be possible to take only one test for each language.

For locations where two or more alternative languages are provided, it will be possible to take the test for only one of the languages indicated.

The tests will be computer-delivered, level barrier and in multiple choice / cloze mode (no speaking - no listening). The test starts from level A2 and, based on the score obtained, you can move on to the next levels (step by step) up to level C1. The test will last a maximum of 60 minutes (if all four levels have been completed) and no online test simulations will be available. To participate in the test, each student must have a personal computer with webcam, microphone, operating system with a browser and have installed the zoom software available at the following address:

# PLEASE NOTE: there will be no further available dates.

As scheduled, there are 3000 places available. There will be a maximum of 250 tests per day (50 per shift) and each shift may be booked as long as places are available.

We recommend you to book your tests as soon as possible to have the widest possible choice.

Test results will be automatically inserted by CLA on your application within 5 working days. The certificate will only be provided to students who complete their Erasmus mobility periods. You can download the certificate directly from your Erasmus personal page.

# ART. 2.4.2 INFORMATION FOR DISABLED STUDENTS AND SERVICES FOR STUDENTS WITH LEARNING DISORDERS

Students with disabilities (as per Art. 3 of Bill N. 104/1992) and/or disabilities equal or greater to 66% are exempt from the computer-delivered language test. They must indicate this on the language test booking form.

The CLA will test student language knowledge on the basis of suitable procedures.





Students with learning disorders (as per Bill N. 170/2010 and DM N. 5669/2011) who require specific aides to complete the test, must indicate this on their language test booking form. Candidates with learning disorders will be given 30% additional time; particular situations will be examined on the basis of the provided certifications.

All requests must be submitted by the language test registration deadline (see Art.2.4.1. "LANGUAGE TESTS") and will be verified by the Office for Students with Disabilities and Learning Disorders, which may request official certifications from the National Health Service or accredited specialists and facilities.

Learning disorder certification must refer to official reading/writing/calculation levels. Diagnoses must be updated after 3 years, if it was issued to a minor.

PLEASE NOTE: students with disabilities or learning disorders, who are resident abroad and intend to enjoy the measures described above, must submit certifications issued in their country of residence together with a sworn translation into Italian or English.

#### ART. 2.4.3 EXEMPTION FROM LANGUAGE TESTS

Only students who meet one of the following requirements are exempt from taking the language assessment test at the CLA, without prejudice to the minimum requirement required by the host institutions::

- 1) Have completed and passed the language assessment test at the CLA for the Erasmus + call for the academic year 2020-21, under the conditions indicated in the previous article 2.4
- 2) Be a native speaker of the language chosen for mobility purposes; according to the directives issued by the Ministry of Public Education with circular letter no. 5494 of 12/29/1982 (ref. CUN of 10/30/1982), the quality of foreign mother tongue subject is recognized "to Italian and foreign citizens only when it is proven that they have completed at least the entire cycle of elementary education and secondary school in the country whose language they intend to teach, in state or private (recognized) schools of the same nationality ". The mother tongue corresponds to level C2 of the Common European Framework of Reference (CEFR).
- 3) Having achieved a minimum level of linguistic competence equal to level A2, certified by an official certificate for at least one of the languages indicated in art. 2.4.1 "LANGUAGE TEST" issued by one of the Certifying Bodies provided for in the CEFR equivalence table, referred to in Annex 1, for the language (s) chosen for mobility purposes.
- 4) Enrolment in a Sapienza degree programme that is held entirely in English. If the student applies for a destination that does not accept English, the **student will have to take the test**. Students who are in this condition are automatically assigned B2 level for the English language. Students who find themselves in this condition are automatically assigned the B2 level for the English language.





- 5) Having obtained the upper secondary school diploma from an international high school recognized by the MUR for at least one of the languages English, French (ESABAC diploma), German, Spanish or Portuguese (the upper secondary school diploma at an international high school corresponds to level B2).
- 6) Having obtained, during the mobility period carried out in the academic year 2019/2020 and 2020/2021, a minimum level of linguistic competence equal to level A2 for one of the languages indicated in art. 2.4.1 "LINGUISTIC TEST" by means of a certificate of linguistic competence level issued by the Language Center of the host University.

**PLEASE NOTE:** the exemptions from language tests can only be used if the language you intend to be exempted can be used to study in the chosen University, and if the latter does not require a level of linguistic competence higher than that is indicated in the exemption documents.

If both of the above conditions are not met, it is still mandatory to take the language assessment test at the CLA.

**PLEASE NOTE:** the documents necessary for the exemption from the language assessment tests must be uploaded in the online application, under penalty of exclusion from the ranking for the chosen University.

**PLEASE NOTE:** the documents necessary for the exemption from the language assessment tests is evaluated by the Commission to verify its validity / suitability. The negative outcome of the evaluation involves the exclusion from the ranking for the specific location University.

PLEASE NOTE: language tests taken as part of a degree programme do not exempt you from the CLA <u>Test.</u> Similarly, declarations issued by professors, even university professors, and language exams will not be considered valid.

## ART. 2.5 OTHER REQUIREMENTS

- This call is not open to students enrolled in other Faculties.
- This call is open to students enrolled in the following PhD courses: 1) Scienze Sociali Applicati 2) Mercati e Istituzioni per lo sviluppo e l'innovazione (ex Economia e Finanza)
- Students who intend to carry out research for the degree thesis must obtain the approval of the Italian supervisor and obtain credit recognition before graduating.

## **ART. 3 GRANTS AND FINANCIAL BENEFITS**

The determination of contributions will be governed by the new regulation of the Erasmus 2021/22 program, conditioned by the approval of the agreement with the Erasmus + Indire National Agency and the University Board of Directors.

#### ART. 3.1 GENERAL ASPECTS

- 1. Grants for mobility are assigned exclusively for academic activities abroad (see Art. 5 "ACADEMIC ACTIVITIES ABROAD"). The mobility period must not exceed 12 months and be completed between 01/06/2021 and 30/09/2022 (Erasmus Year).
- 2. In order to benefit from Erasmus grants, the student assigned to the mobility must, **strictly before departure**, accept the terms of the financial contract and follow the instructions that will be provided at the time of assignment of the mobility itself.

ART, 3.2, EU GRANTS





The loans are to be considered as a contribution to the higher expenses related to the stay abroad. The determination of community contributions will be governed by the legislation of the new Erasmus program (2021/2027) (see art.3) and the relevant information will be available at the link: <a href="https://www.uniroma1.it/it/pagina/esoneri-e-contributi-monetari-gli-studenti-partenza">https://www.uniroma1.it/it/pagina/esoneri-e-contributi-monetari-gli-studenti-partenza</a>

The use of the community contribution is incompatible with further grants deriving from other programs / actions funded by the European Union.

In case of exhaustion of EU funds or if the student benefits from the simultaneous allocation of other university or EU funding, it will be possible to assign the student the status of "Erasmus zero eu-grant" which allows them to benefit from the facilities related to mobility, without the community contribution.

#### ART. 3.3 ADDITIONAL MUR AND SAPIENZA FUNDING

The MUR and Sapienza contributions will be paid to students who are not enrolled in years subsequent to the first out of course (for the calculation, reference will be made to the year of enrollment at Sapienza, even in the case of transfer of the course).

In any case, the MUR contribution will be assigned on the basis of the ISEEU 2021 declaration (ISEE for the right to university study DPCM 159/2013). Those who have not obtained by 31/12/2022 the recognition of at least 6 CFU through the relative procedure, will be required to return the total of the aforementioned contribution to be finalized with the digitized validation procedure to be activated through the Erasmus personal page.

In case of mobility for "thesis research" only, the number of credits must not be less than 3. The above limits do not apply to **PhD students**.

The candidate who intends to benefit from the MUR integration must request the calculation of the ISEEU 2021 at a CAF and authorize its acquisition on the INFOSTUD platform. The data must be available on Infostud by 30/10/2021 to allow its management for the purposes of this announcement.

The candidate who cannot obtain the ISEEU 2021 (foreign student not residing in Italy / foreign student residing in Italy who is not autonomous and with family members residing abroad / Italian student residing abroad not registered with AIRE - Register of Italians Resident at 'Abroad) must request the 2021 ISEE-U from a CAF and deliver it to the competent Administrative Secretariat by 30 October

PLEASE NOTE: All students / doctoral students, postgraduates who in any capacity are exempted from submitting ISEEU for the purpose of paying taxes to benefit from the supplementary MUR contribution, must still apply for the Iseeu 2021 (Isee for the right to university study).

IN THE LACK OF ISEEU / ISEE-U PARIFICATO on the infostud platform, the student will not receive the MUR integration.

# ART. 3.4 ADDITIONAL FUNDING FOR DISABLED STUDENTS AND/OR STUDENTS WITH SPECIAL NEEDS

- 1. In order to allow a wider student participation in the mobility programme, Indire the National Agency for Erasmus+ allocates grants intended to support disabled students and/or students with special needs.
- 2. Students must communicate their disability/special need both through their application form and upon acceptance, if assigned a mobility period.

#### ART, 3.5 GRANTS FOR MOBILITY TO SWITZERLAND

- 2. It should be noted that **SEMP students** are not entitled to receive EU grants, including grants for special needs, whereas they are entitled to the additional MIUR and Sapienza grants (except as provided by Art. 3.3 "ADDITIONAL MIUR AND SAPIENZA FUNDING").

#### ART. 3.6 TAXATION OF THE ERASMUS + GRANT

Under Article 1, paragraph 50, Law No 208 - 28.12.2015, grants for international mobility are subject to the exemptions provided by Article 1, paragraph 3, Decree-Law N. 105 - 9 May 2003, converted with amendments into Law N. 170 - 11 July 2003, except further amendments.

## **ART. 4 AVAILABLE DESTINATIONS AND PLACES**

- 1. Students may apply from a minimum of n. 1 to a maximum n.2 destinations.
- 2. The order of priority indicated at the time of application is binding, both for the candidate and for the Erasmus Office for the purpose of assigning the location, in the event that the candidate is the winner in more than one location.

When choosing the venue, it is essential to pay attention to the language level required to be able to attend the lessons and take the exams (see art. 2.4 "LANGUAGE REQUIREMENTS"). In particular, if the host University requires a specific language certificate, the student must be in possession of it before departure (at the latest during the application phase), otherwise they will not be able to take advantage of the mobility at that location. Therefore, in the event of a tie, the location is assigned to the candidate who has already uploaded the language certificate required by the host University in the application.

The language requirements indicated in the "available locations and places" table are established by the Partner Universities and are subject to change without notice.

**PLEASE NOTE:** For the choice of locations, the student must take into consideration the possibility of being tested on a maximum of two languages.

For destinations where two or more alternative languages are provided, it will be possible to take the test for only one of the languages indicated in the table "locations and available places".

The language of study abroad can only be one for each chosen destination and competence in that language is assessed with a test at the CLA or pursuant to art. 2.4.3 "LINGUISTIC TEST EXEMPTION".

The candidate **must** verify the consistency of the training offer in the chosen study language and compatibility with their training path.

For the choice of location, the candidate must refer to the training offer of the specific Faculty / Department / School partner of the DiSSE Department. For the choice, he must orient himself according to the study area, defined by a code and a descriptive text (eg 0314 - Sociology and cultural studies), indicated in the locations of the following call.





Each Faculty / Department / School partner of the DiSSE Department establishes its own rules regarding the possibility of attending lessons and taking exams outside the reference Structure and / or the study area. **Students have to inquire independently about these rules**.

It is necessary to make sure that **the study level** of the exchange concerns your own cycle of studies: 1 = first cycle (Bachelor degree), 2 = second cycle (Master degree), 3 = third cycle (Doctorate). The application for Universities whose level of studies does not concern your own cycle of studies **is not valid**.

- 2 = Postgraduate (Master, One-cycle Degree);
- 3 = Doctoral (Specialization or Doctoral Programmes)

**PLEASE NOTE:** If the exchange also concerns the study level 3, 1 place is reserved for the candidate enrolled in a PhD course. In case of candidacy of 2 or more enrolled in a PhD course, the reserved place is assigned to the one with the highest score. If no application is submitted by students enrolled in a doctoral course, the reserved place is available for students enrolled in degree courses (levels 1 and 2), if included in the exchange agreement.

**PLEASE NOTE: Available places and destinations** are subject to modifications if the partner universities or national and European organisations regulating the programme introduce variations. Before applying, please independently verify the feasibility of studying at your preferred destinations on the websites of the individual universities.

- 4. **The mobility period** indicated in this call is based on inter-university agreements. These periods may vary only in specific circumstances in which the student:
  - Begins the mobility period during the second semester,
  - Has already enjoyed periods of mobility during the same cycle of studies (see Art. 2.2.). In this
    case, the maximum mobility period will be reduced to satisfy the upper limit of 12 months per
    cycle of studies and 24 months for one-cycle degree programmes, in agreement with the host
    university.





- 5. It will not be possible to guarantee the beginning of a mobility period in the 1<sup>st</sup> semester for destinations that have a deadline (for the submission of student documents) that is not compatible with the schedule of this call (Art. 14 "END OF PROCEDURE").
- 6. When choosing the destination for the mobility, please pay attention to the language level required from the host University. The requirements in the table have been specified by each partner University. The interested students are anyway suggested to personally check the real conformity of these requirements regarding the chosen destinations.

## **ART. 5 ACADEMIC ACTIVITIES ABROAD**

- 1. Students must indicate the didactic activities they intend to pursue abroad on the application form. The indicated activities are not final and may be integrated upon completion of the official Learning agreement (Art. 8 "LEARNING AGREEMENT") that will have to be approved by the Degree Programme Academic Mobility Coordinator (RAM).
- 2. Admissible mobility activities are:
  - Attendance of courses and passing of exams.
  - Preparation of the degree thesis (in this case it is necessary to take at least one exam for a minimum of 3 CFU) and/or doctoral thesis.
  - Curricular traineeship (only if relevant) and if carried out within the host University.
- 3. - 4. **PhD students and candidates enrolled in Specialization Schools**, after having verified their eligibility for a mobility period abroad, must agree on the educational programme abroad with the Coordinator of the PhD Programme in which they are enrolled. ## **ART. 6 APPLICATION**

### ART. 6.1 DEADLINES AND SUBMISSION

- 1. The deadline for submission of the on-line application form is on the 15/03/2021, at 2 pm (Italian time).

- 3. In order to submit an application form, **you must use your university e-mail account** (familyname.studentnumber@studenti.uniroma1.it).

This will be the <u>only official means used for communications</u> for this call and subsequent procedures.





4. Once the application has been completed, each candidate will receive a report of all the data submitted at his/her university email address. Thus, all applicants must verify that they receive this report and that all the data submitted is correct. Any error must be immediately reported to the Faculty Erasmus Administrative Coordinator - mail to: erasmusdisse@uniroma1.it / flavia.orlandi@uniroma1.it.

PLEASE NOTE: the <u>only</u> valid receipt for your application is the e-mail you receive on your university account.

#### ART, 6.2 DOCUMENTS TO SUBMIT

In order to correctly complete the application process, students must fill out all fields of the on-line form and **verify the upload of the following documents**, which are an integral part of the application process:

- 1. Scan of a valid identity document (mandatory).
- 2. <u>Documents necessary for the exemption from linguistic assessment tests (art. 2.4.3) under penalty of exclusion from the ranking for the chosen location.</u>

Please Note: If the required documentation is not uploaded by the deadline, or the declared/self-certified information is not correct, the application will be rejected.

#### **ART. 7 RANKING**

## ART. 7.1 RANKING PROCESS

The rankings, one for the CIVIS alliance offices and one for the other Erasmus + destinations they will be formulated by a Commission that will evaluate the applications and assign the scores, according to the criteria described below.

#### ARE ELEMENTS OF EVALUATION:

1. Academic merit: 0 - 2000 points (criterion applied only to students enrolled in a Bachelor or Master Degree course).

Academic merit is calculated by applying the following formula:

number of ECTS acquired / year of studies x the weighted average of the marks.

For students enrolled in a Master Degree course, the 180 credits of the Bachelor career are added to the credits acquired.

For students enrolled in a Master degree program, the year of the course is determined by adding the 3 years of the Bachelor career to the year of enrollment (I or II) (e.g. if enrolled in the first year, the year of the course is 4: if enrolled in the second year, the course year is 5).

For out-of-course students enrolled in a Master Degree program, the years out-of- course are added to the year of the course determined as indicated above (e.g. if 1 year out of course, 5 + 1 = 6).

For out-of-course students enrolled in a Bachelor Degree program, the year of the course is determined by adding the years out of course to the natural duration of the career (e.g. if 1 year out of course, 3 + 1 = 4).

For students enrolled in a Master Degree program, the weighted average of the Bachelor career is also taken into account to determine the weighted average of the marks. The weighted average of the Bachelor career is obtained from the Bachelor graduation mark, according to the following calculation: 31 x Bachelor graduation mark / 111. The result is added to the weighted average of the Master degree career and then divided by 2.





For students of a Master Degree program, who have obtained a three-year degree abroad, the Bachelor graduation mark is 88/110 (arithmetic average rounded down, between minimum and maximum degree mark in Italy).

**PLEASE NOTE:** the average 30 with honors is calculated as 31; the graduation mark 110 with honors is calculated as 111.

## PLEASE NOTE: the following do not concur to your GPA calculation:

- Exams taken abroad during Erasmus periods that have not yet been officialised as they refer to exams still in the process of being validated;
- Extracurricular exams (former Art. 6 Regio Decreto N. 1269/38) as they do not count for CFUs necessary for degree and are not used to calculate GPA;
- Exams for single courses that have not been recognised as part of the degree programme (Bachelors, Masters, one Cycle) for which the student is currently enrolled;
- Integrated exams and elective educational activities (ADE) if the credits related to all the modules of each integrated exam have not been successfully completed;
- Exams cancelled due to lack of prerequisites;
- Exams declared to have been taken, but which were only booked and not taken, or not even booked.

## 2. Linguistic competence: 0 - 2000 points.

linguistic competence is evaluated accordingly to the art. 2.4, with the following scores: A2= 50 points; B1=500 points; B2=1000 points; C1=1500 points; C2=2000 points.

In assigning mobility periods, in case of identical scores, priority will be given to students who have not had a prior Erasmus experience for study and placement/traineeship.

The Commission will produce a ranking of candidates based on the above-mentioned criteria and publish the **provisional ranking** at the following links:

The ranking will be considered definitive if **within natural and consecutive 10 days** after the publication, no requests for revision are submitted to the Departmental Erasmus Office mailto: <u>mail to: erasmus.disse@uniroma1.it</u>/flavia.orlandi@uniroma1.it.

## **Revision of the provisional ranking:**

The request for revision suspends the start of the aforementioned term.

Revision is possible only for material or calculation errors.

The request must be preceded by an informal access according to L. 7 August 1990 n. 241.

Instances not preceded by informal access are inadmissible and will not be considered.

The requests for review are evaluated by the Commission which within 3 working days and decides to reject or accept them.

There are no appeals against the decision.

If the revision, once accepted involves a modification, the provisional ranking is published again with the appropriate corrections.





After the publication of the provisional ranking corrected following a revision, the residual deadline for submitting revisions requests continues to run.

After the deadline for submitting revisions requests, the ranking becomes definitive.

The Administration to act in self-defense.

The final ranking will be published on the Faculty site at:

Times and methods of publication of the rankings:

2 rankings (provisional and definitive) will be drawn up and published consecutively with the following order and names:

- ranking (provisional and definitive) first chosen Universities;
- ranking (provisional and definitive) second chosen Universities;

Within these there will be specific rankings relating to individual Universities, possibly differentiated by study area.

The rankings indicate: Universities identification code, study area, number of available places, matriculation numbers and total scores of the winners written in red, matriculation numbers and total scores of the eligible non-winners written in black.

The matriculation numbers of excluded candidates do not appear in the rankings or from the entire selection procedure or from the specific ranking.

Exclusion from a specific ranking but not from the entire selection procedure (the list of those excluded from the entire selection procedure is the subject of a specific publication), does not affect the possibility of assigning a mobility grant in the following ranking or in the procedure for residual offices.

Exclusion from a specific ranking may be due to: wrong area of study, wrong level of study, lack of language requirements.

# ART, 7.2 ACCEPTANCE OF MOBILITY PERIOD

The winners, even of the provisional rankings, and without prejudice to any changes due to revision, are the assignees of the seats won.

The assignee is bound to the won University: he must give his/her acceptance and no other University can be assigned to him/her.

The assignees, after the publication of the final ranking, receive a notification email at the institutional address, with instructions for the acceptance. Acceptance must be communicated within 7 natural and consecutive days from the receipt of the notification email.





The missed respect of this deadline will be considered as a silent renunciation.

The renunciation, silent or expressed after acceptance, entails the definitive exclusion of the candidate from the entire selection procedure: you will not be entitled to the assignment of other Universities.

The **final** assignment of an Erasmus+ mobility requires:

- Submission of necessary documentation (if required);
- Formalization and approval of the Learning Agreement by the Academic Coordinator for International Mobility (RAM);
- Finalization of the financial contract between the student and Sapienza, according to the indications that will be provided at the time of assignment of the mobility.

Presence in the final ranking does not automatically mean the student will enjoy the mobility period, as this depends on the background check conducted by the Faculty and host university on requirements and pre-requisites.

PLEASE NOTE: the student's mobility is subject to acceptance by the foreign Institution (i.e., academic curriculum, language skills) which may require further certificates or reject the application on the basis of regulations that are not specified in the inter-institutional agreement signed with the partner University and concerning, for example, the teaching regulations.

#### ART. 7.3 REFUSAL OF THE MOBILITY AND REPLACEMENT

The acceptance of the mobility is a serious commitment by the candidate. Thus, selected candidates are expected to limit refusals, after acceptance or at the beginning of the mobility period, on account of serious and proven matters of force majeure, which must be communicated in writing and duly justified to allow replacement by the first reserve candidate.

The seats become available by renunciation (silent or express) are assigned to eligible non-winners who are in a useful position in the specific ranking (University and study area). In the absence of eligible non-winners or if possibility of scrolling is over, the seats still available are assigned in the following ranking, to candidates who have chosen Universities with vacancies.

The described system of scrolling applies until the publication of the definitive ranking for the second Universities chosen.

Scrolling of the ranking are not published.

#### ART, 7.4 RESIDUAL DESTINATIONS

# Preamble:

In order to assign as many residual seats as possible, in compliance with the linguistic requirements established by the partner Universities and the Degree courses of eligible non-winning candidates, the following discipline is prepared.

Are considered residual the seats that after the publication of the definitive ranking for the second chosen Universities are not yet assigned to any candidate.

Are considered eligible non-winning the candidates whose linguistic competence has been evaluated by a test at the CLA or by exemption from tests according to art. 2.4.3, and that are no winners in any of the published rankings.





Are not considered eligible non-winners those who are winners of a seat in one of the published rankings and have renounced (tacitly or expressly).

Mobility for residual Universities takes place **exclusively in the second semester**.

A list of eligible non-winning candidates and residual Universities is published at the links:

The eligible non-winners receive from the departmental Erasmus Office at the institutional email address, an invitation to choose the residual Universities, by filling in a specific form, indicating the Erasmus code of the chosen Universities and the study area. It is possible to indicate up to 5 residual Universities. For the assignment, the order of choices is binding for both candidates and for the Erasmus Office.

The form must be returned to the Erasmus Office: mailto: <a href="mailto:">erasmus.disse@uniroma1.it</a> / flavia.orlandi@uniroma1.it , within 24/07/2021, in order to respect the deadlines ( for nominations and applications ) relating to the second semester and established by the host Universities.

The choice must be made according to the criteria and rules of arts. 2.4 and 4, if applicable and not derogated from the specific regulations for the residual Universities. In particular, candidates must verify that the chosen Universities have an academic offer compatible with their own path. Candidates must also have the language skills required by partner Universities, already assessed by the test taken at the CLA, or the documentation for exemption (art. 2.4.3).

#### **PLEASE NOTE:**

if the host University requires a specific language certificate, the students must have it before departure (at the latest during the enrollment in the won University), otherwise the mobility won't be possible. Therefore, in case of a tie, the seat is assigned to the candidate who has already uploaded the language certificate requested by the host University in the application.

The choice of residual Universities that does not comply with the aforementioned criteria is not valid.

The Erasmus Office evaluates the validity of the choices made, assigns the seats.

The assignment is made based on the **priority of the choice**.

The priority is determined on the basis of the **date and time of receipt** of the emails with the indication of the chosen Universities.

Candidates who, at the end of the procedure, are not assigned a location, are not entitled to make other choices.

After the assignment, the candidate receives a notification at the institutional email address for and have to accept the seat.

After acceptance, the assignee remains bound to the won University which can no longer be changed.

In case of subsequent renunciation, no other choices are possible.

The Universities still available at the end of the procedure remain unassigned.

A ranking is not published for the remaining Universities.

No revision requests are available.

The right of access is exercised according to Law 241 / '90

## **ART. 8 LEARNING AGREEMENT**

- 1. All students who have accepted their assigned destination must complete an official Learning Agreement (LA). The LA is a document that is prepared before departure and defines the academic activities that will be completed abroad.
- 2. The LA, which guarantees the recognition of credits obtained for passed exams and thesis research work conducted abroad, must be:
- Completed on-line by students on their personal page: https://relint.uniroma1.it/pp2013/login.aspx





- Approved on-line by the Academic Coordinator for International Mobility (RAM The full list is available at <a href="https://www.uniroma1.it/it/pagina/coordinatori-e-responsabili-accademici-mobilita-internazionale-0">https://www.uniroma1.it/it/pagina/coordinatori-e-responsabili-accademici-mobilita-internazionale-0</a>
- Signed by the student
- · Approved (stamp and signature) by the partner university
- the scan of the LA complete with signatures and stamp of approval must be uploaded in the upload section of the personal page before departure for the host site.

The completion and approval of the Learning Agreement are mandatory and binding to enjoy your mobility period. Failure to do so will cause your exclusion.

The LA includes the exams you plan to take or other didactic activities that will ensure you earn at least 6 CFUs (or at least 3 CFUs for thesis research mobility). PhD students are excluded from this limit.

Students who do not earn at least 6 CFUs (or at least 3 CFUs for thesis research mobility) will be forced to return their mobility funding to MUR. This limit does not concern PhD and Specialisation students.

We inform, in particular candidates who intend to carry out research for <u>the degree thesis</u>, that some partner Universities require a L.A. with a certain number of ECTS for exams, up to a maximum of 30 for 1 semester of mobility. Therefore, it is advisable to have ample margin in the definition of the L.A., with respect to the limits above indicated.

#### ART. 9 ONLINE LINGUISTIC SUPPORT AND EU SURVEY

#### ART. 9.1 ONLINE LINGUISTIC SUPPORT (OLS)

- 1. The Erasmus+ Programme requires selected candidates to take an on-line language skills assessment, both before and after the mobility period, if the language used abroad and indicated in the Learning Agreement is one of the following: Bulgarian, Czech, Croatian, Danish, Dutch, English, Finnish, French, Hungarian, German, Greek, Estonian, Irish, Latvian, Lithuanian, Maltese, Polish, Portuguese, Rumanian, Slovakian, Slovenian, Spanish and Swedish, except students who are assigned a mobility to Switzerland.
- 2. On the basis of the result in the assessment test, the student may receive a licence for an on-line preparatory language course to prepare for the mobility period
- 3. Procedures concerning the language test will be communicated directly to the student at the email address provided on the application form.

# ART. 9.2 EU SURVEY

At the end of the mobility period, students (with the exception of students who are assigned for mobility period toward Switzerland) must complete the EU SURVEY.

Information concerning the procedures to be followed will be sent directly to your university e-mail account.

#### ART. 10 PROCEDURES AND LOGISTICS





- 1. In order to prepare their curricular project at the host university, students should carefully examine all available information on the university websites before applying. In fact, this information is binding for receiving the mobility grant.
- 2. For degree, PhD or Specialisation thesis work, students must agree on the project with their Italian supervisor and Academic Mobility Coordinator, based on the agreement with the partner professor at the host university.
- 3. At the end of their courses, Erasmus students must take the planned exams following the programmes and procedures provided for students of the host university. Academic activities will be recognized as indicated by the Faculty and the "Rules for Student Mobility and Recognition of Study Periods and Training Abroad". Credits for exams taken at host universities must be acquired respecting all the rules and regulations of degree programme curricula.
- 4. Students must autonomously acquire information regarding housing opportunities provided by destination universities. Moreover, students are also responsible for informing themselves about:
  - Health Assistance in the host country, requesting information from their local health office, diplomatic missions or at the following link

  - Entrance into the host country, checking for requirements with embassies and consulates (in Italy for non-EU citizens).
- 5. Laws regulating the entrance of non-EU students in countries participating in the Erasmus+ Programme are based on the nationality of these students. Students are responsible for promptly obtaining information and all the documents needed to be admitted and allowed to sojourn in the destination country from the relevant diplomatic missions.
- 6.
