MAIN PROJECTS

Design and actuate the Data Governance Strategy for a major Italian Insurance Group

BRIEF

Design of the Data Governance strategy and framework, identification of the multi-year adoption plan and actuation of the key streams for the Data Governance adoption of the Group

SOLUTION

In the changing environment, the Insurance Group wanted to develop a modern approach to manage data, to support business while being compliant with in force regulations.

The project aimed at design and execution of the overall Data Governance Strategy. Key activities have been:

- Definition of the overall Data Governance Framework with all the key elements to be designed and implemented;
- Definition of the approach for the Entire Group, defining the Legal Entities involvement;
- Creation of the multi-year plan to adopt the framework to make the Group able to perform the modern Data Governance approach;
- Sizing of the involved structures to apply the Data Governance approach;
- Design of roles and responsibilities;
- Definition of key processes;
- Definition of the plan to comply with in force regulation and execution of activities to fill compliance gap.
- Defined and performed the Data Governance Training program to key HeadQuarter stakeholders and the key Legal Entities stakeholders.

RESULTS

Group Data Governance framework established, Legal Entities involvement, Compliance with in force regulation (also passed an IVASS inspection)

Data Governance and Data Management Capability Maturity Assessment for a major Insurance Group

BRIEF

Assessment of the current Data Governance and Data Management Assessment to design an evolved business driven approach to Data Governance and Data Governance.

SOLUTION

Design of a strategic assessment of all the key elements of Data Governance and Data Management, leveraging the international DAMA standard together with the several experiences gained in similar project to look at concrete items.

Realization and use of a digital solution to perform the assessment and measure the current maturity compared to the regulatory requirements and to the market maturity (benchmark).

To perform the assessment, we created the training on Data Governance and Data Management targeted to key stakeholders (Directors and their first reports).

The results have been used to define the target maturity level desired by the Group. Based on this, the evolution Roadmap has been designed.

RESULTS

Analyzed the Data Governance and Data Management maturity for 18 business data areas of the Group and the entire IT; Training on Data Governance and Data Management to Directors and their first reports; Clear list of gaps towards the targets of the Group; List of actions to evolve the Data Governance and Data Management framework; Multi-year roadmap design attraction campaign that revolved around two objectives: to address a target audience through social engagement and bold calls to action; to provide complete program information.

Design and evolution of the Internal Governance to comply with Solvency II

BRIEF

Definition of the entire Governance system to comply with the Solvency II Pillar II.

SOLUTION

Organizational and process analysis aimed at reviewing the entire Governance System, in terms of roles and responsibilities, organizational structures, processes, controls, methodologies, ecc to comply with Solvency II requirements and in line with the Group approach.

Key activities have been:

- Review of the all Risk Management policies (almost 15 policies);
- Definition of the best organizational solution for the Actuarial Function;
- Set up of the Operational Risk Management methodology and run of the first execution;
- Review of the ORSA process;
- Set up of the Data Quality approach;
- Governance of the overall Solvency II program;
- Training to the Board of Directors, to the Executive Committee and to all the employees.
