Licentiate in Law in 1989 and Doctor of Law in 1998, she is currently Professor of Civil Law, always at the University of Barcelona. She has already completed 4 consecutive six-year research periods. In 2002-2007 she obtained a Jean Monnet module and during the academic years 2015-2018 and 2019-2022 she was -and still is- the holder of a Jean Monnet Chair, all of them projects awarded by the European Commission, by public competition, for teaching and researching in the field of European private law. Fellow of the German DAAD (2003), of the Foundation Alexander von Humboldt (2006-2007) and member of the European Law Institute (2010), she has also given lectures and conferences at different universities from Spain (Univ. Rovira i Virgili, Tarragona), America (Univ. of Puerto Rico, Univ. Autónoma de Chile), Europe (Münster, Porto, Turin, Venice, Verona) and Asia (East China and Shanghai universities of Political Science and Law), Shanghai; Renmin Law School, Beijing; China University of Political Science and Law, Beijing). She currently teaches European property and contract law at the University of Barcelona and also at the University of Münster (FFA programme) and cooperates with an educational project of the Legal Clinic of the University of Barcelona on housing and mortgage loans. Member of the Contract Law Section of the General Codification Commission and of the Legal Advisory Commission, both bodies of the Government of Catalonia. As a member of the Group Acquis, she has taken part in the development of European Private Law through the Network of Excellence created by the Sixth Framework Programme for Research of the European Union (2005-2009). She has twice received the Miguel Casals Colldecarrera Research Prize from the Fundació Cultura Catalana (4th and 9th editions, 1999 and 2009). Her academic responsibilities include the evaluation of research projects at the national level, as well as reviewing papers for different journals. Since 2014, she is coordinating the Consolidated Research Group on Catalan Civil Law. She is an advisor to the Commission of Lecturers and Collaborating Professors in the field of Social Sciences of the Agency for the Quality of the University System of Catalonia (since 2015) and a Member of the Permanent International Commission of Scientific Advice of the Centre for Economic Legal Research of the University of Porto (since 2018). She is currently supervising two doctoral theses.
